

ELECTRICAL CONTRACTOR INSTALLATION PERMIT FEE SCHEDULE

As per Safety Standards General Regulation 12, a person must obtain the appropriate permit from the regulatory authority **before performing regulated work** or using a regulated product, unless exempted from doing under the Act. Provide an accurate scope and detail of installation work, as per Safety Standards General Regulation 14; amendments will be subject to By-law 14577 schedule "A" (25.)

As per the City of Surrey's Electrical Safety By-law 15596, a separate electrical permit shall be obtained for each building or structure in which electrical work is being obtained. Where a two or more buildings share a common underground parkade, a separate electrical permit shall be obtained for the parkade.

A **\$228.00** (GST included) Compliance Re-attendance/Site re-visit fee will be imposed whenever a site visit was requested, and the work was not ready for review including a site visit that was requested and the work was not completed for review (there were significant deficiencies which indicated the work was not checked by the FSR prior to calling for review and not complete.)

- a) Second and subsequent Compliance Re-attendance to that in paragraph (b) will impose a Re-attendance fee of **\$228.00**.
- b) Amendment of permit for additional or other work at site SSG 14 On payment of any required fee, a safety officer may amend a permit to allow additional regulated work to be performed under the permit. See By-law 14577 schedule "A" (25.)
