INSURANCE REQUIREMENTS	
<p>The Licensee shall obtain Comprehensive General Liability Insurance protecting the City of Surrey against liability for bodily injury, death or property damage, arising out of the activity. The minimum shall be \$5,000,000.00 inclusive per occurrence, maximum deductible \$500.00 per occurrence, with a cross liability clause. Acceptable proof of Insurance must be received by the Surrey Parks, Recreation & Culture Department prior to the use of any facilities covered under this permit.</p>	
CANCELLATION POLICY	
<p>Tournaments that are cancelled with less than 60 days prior notice will receive a credit or refund only if the reserved time can be resold. Cancelled tournaments also lose their 'historical' status and future applications are treated on a 'first come first serve' basis.</p> <p>*When an event is cancelled due to adverse/hazardous weather, a written/e-mail request for a credit or refund must be received by the City of Surrey no later than 48 hours after the cancellation of the booking*</p>
