WHEREAS pursuant to Part 7 of the <i>Community Charter</i> , S.B.C. 2003, c.26 as amended (the " <i>Charter</i> "), and the regulations passed pursuant thereto, the Council of the City of Surrey may, by bylaw, provide a service that the Council considers necessary or desirable for all or part of the municipality;			
WHEREAS the Council of the City of Surrey has determined that it is necessary and desirable for the City to provide cultural and recreational services, including establishing, operating and maintaining related capital projects, for the convenience and well-being of the residents and businesses within the City;			
WHEREAS Section 200 of the Charter allows the imposition of a parcel tax on all properties within the City, to fund all or part of the cost of providing cultural and recreational services;			
NOW THEREFORE, the City Council of the City of Surrey ENACTS AS FOLLOWS:			
1. This bylaw may be cited for all purposes as "Capital Parcel Tax Bylaw, 2015, No. 18395".			
 A parcel tax in the amount specified in Schedule "A" is hereby imposed upon the owners of all land or real property in the City of Surrey as a single amount for each parcel. 			
3. The Collector is hereby directed to prepare a parcel tax roll pursuant to Section 202 of the <i>Charter</i> .
