

CITY OF SURREY

BY-LAW NO. 13738

A by-law to amend the provisions of "Surrey Official Community Plan By-law, 1996, No. 12900," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. That portion of the map designated as Schedule A. Land Use Designation Map, Division A of "Surrey Official Community Plan By-law, 1996, No. 12900," as amended as shown outlined black on the plan attached hereto and designated as "Amendment to Schedule A, Land Use Designation Map is hereby amended as follows:

FROM "URBAN (URB)" TO "MULTIPLE RESIDENTIAL (RM)"

All or portions of the lands shown in heavy outline on a Survey Plan attached hereto and forming a part of this By-law as Schedule A, certified correct by Eric Peterson, B.C.L.S., on the 3rd day of February, 1999, containing 16,487 square metres and called Block A, and more particularly described as follows:

Parcel Identifier: 017-021-031

Portion of The North Half of Lot 14 Except Parcel "A" (Explanatory Plan 13215) Section 25 Township 2 New Westminster District Plan 1654;

(Portion of 8495 - 164 Street)

Parcel Identifier: 012-268-321

Portion of Parcel "A" (Explanatory Plan 13215) North Half Lot 14 Section 25 Township 2 New Westminster District Plan 1654; and

(Portion of 8483 - 164 Street)

Parcel Identifier: 012-268-364

South Half Lot 14 Section 25 Township 2 New Westminster District Plan 1654.

(8467 - 164 Street)

2. This By-law shall be cited for all purposes as "Surrey Official Community Plan By-law, 1996, No. 12900, No. 15 Amendment By-law, 1999, No. 13738."

PUBLIC HEARING HELD thereon on the 21st day of June, 1999.

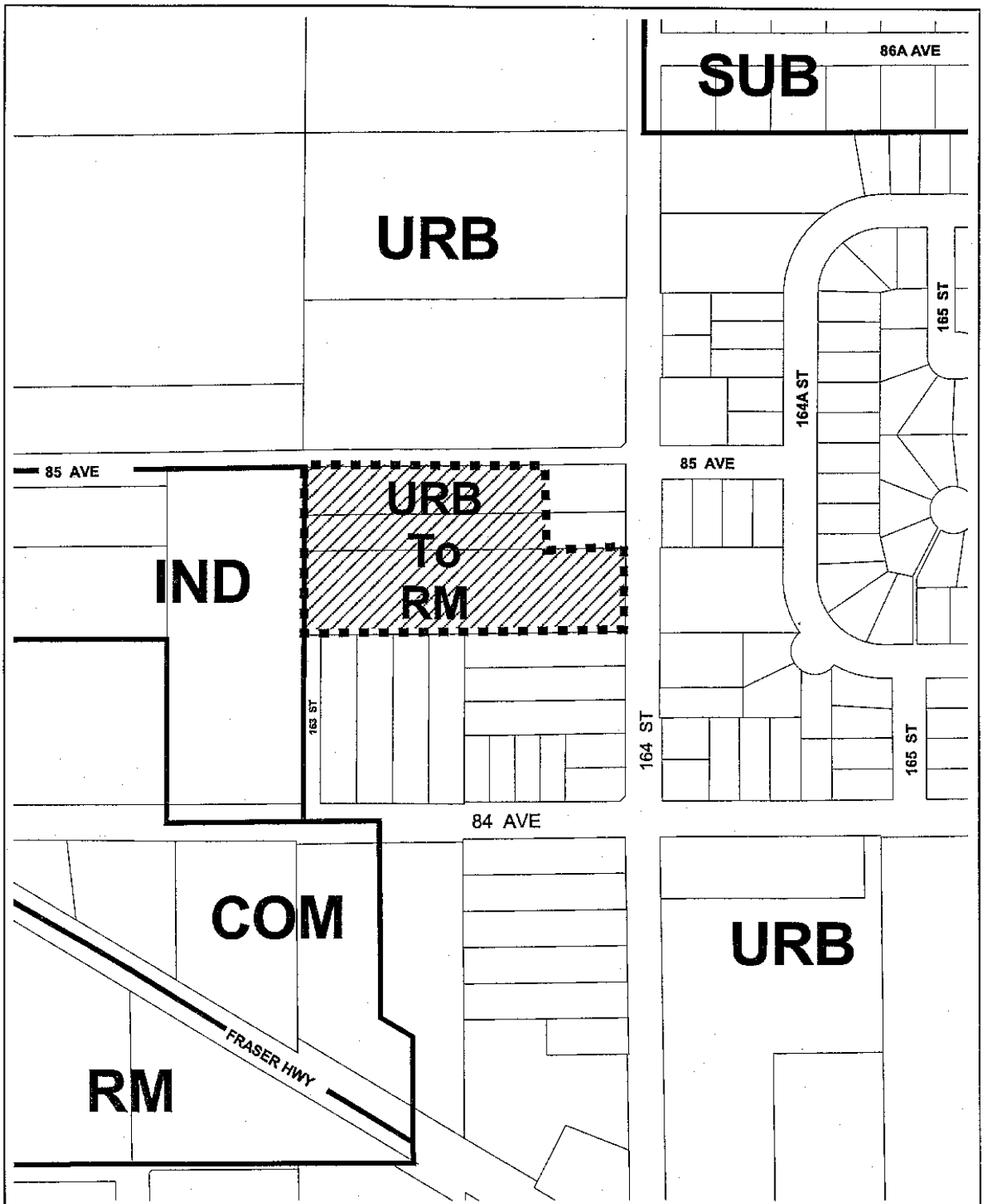
PASSED THIRD READING on the 21st day of June, 1999.

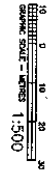

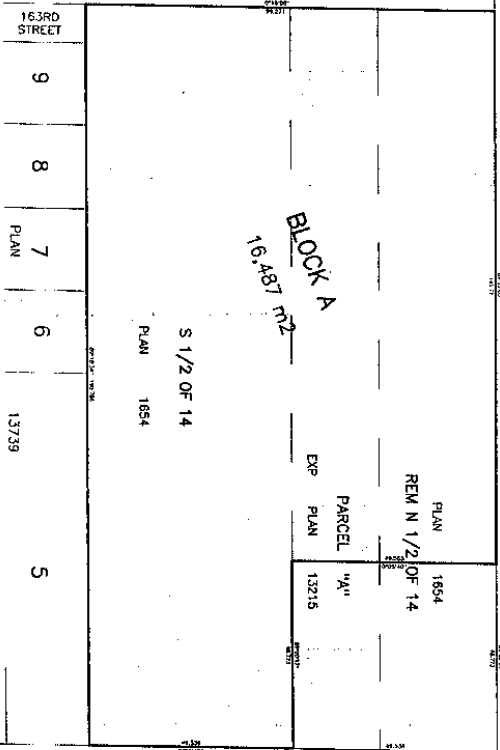


LMS303 PLAN NWP87674
