Every dog over the age of three months is required by the City of Surrey to have a licence. Any dog deemed dangerous requires a dog licence immediately. Licences may be purchased at the Property & Payment Services Section at City Hall. The Surrey Animal Responsibility By-law, 2017, No. 19105, also regulates that a maximum of three dogs are allowed on a residential lot in Surrey, unless a hobby kennel licence has been issued.

Dog Deemed Dangerous	\$500.00

* Copy of Spayed/Neutered documentation is required. Original documents will not be returned.

The dog licence is valid for one year from the date of purchase. A renewal will be sent to you prior to the dog licence expiry date.
