#### **Preface**

Every five years, Statistics Canada conducts a Census of Population in order to develop a statistical portrait of Canada and its people. The most recent Census was conducted in May 2011.

At the time of the last Census, Statistic Canada replaced the long form Census that collected social and economic data with a voluntary National Household Survey (NHS). The 2011 Census questionnaire consisted of the same eight demographic and linguistic questions that appeared on the 2006 Census short-form questionnaire, with the addition of two questions on language. The content of the new NHS is similar to that of the 2006 Census long questionnaire; however, changes were made to some questions and sections of the questionnaire. For example, in the 2011 NHS changes were made to the questions used to measure Aboriginal identity; a new component of income is measured; and, the universe for determining generation status was expanded to include the entire population.

#### Comparability

The Global Non-response Rate (GNR) is used to ascertain the level of non-response to the National Household Survey. Due to the voluntary nature of the survey, the NHS is subject to greater non-response bias.

Change in survey method or content can affect the comparability of the data over time. Statistics Canada states that it is impossible to determine whether, and to what extent, differences in a variable are attributable to change or to non-response bias. As a result, caution must be exercised when NHS estimates are compared with data from the 2006 Census long form.

#### Fact Sheet Overview

The community demographic profiles in this series provide a comparison between the current and previous censuses, Surrey and key Metro Vancouver municipalities, as well as between each of Surrey's six communities: Cloverdale, Fleetwood, Guildford, Newton, South Surrey, and Whalley. City Centre is also identified as a sub-community planning area within Whalley.

For the purpose of this and other facts sheets in the series, the term "National Household Survey" (NHS) refers to the National Household Survey of Canada conducted by Statistics Canada. The voluntary survey collected social and economic information about the people of Canada between May and August 2011. The term "Census" in this document refers to the Census of Population conducted by Statistics Canada on May 10, 2011. The Census provides information about the people and housing units in Canada.

#### CITIZENSHIP AND IMMIGRATION


The 2011 National Household Survey (NHS) collects information on the place of birth, parents' places of birth, citizenship and immigration status of people living in Canada. This data is used to produce information on the movement, generation status, and diversity of Canadians.

An immigrant refers to persons who are or have been a landed immigrant / permanent residents. This person was granted the right to live in Canada permanently by immigration authorities. A non-immigrant is a person who is a Canadian citizen by birth.

#### **CITIZENSHIP**


Citizenship is the legal citizenship status of a person, by birth or naturalization. A person may have more than one citizenship.

Over the past 20 years, the share of the population with Canadian citizenship in Surrey has remained relatively constant. In 2011, 88.1% of Surrey's population was a Canadian citizen, only marginally down from 88.5% in 1991.



### Citizenship in Surrey's Communities


In 2011, South Surrey (93.3%) and Cloverdale (94.6%) had the greatest proportion of residents with Canadian citizenship. Comparatively, in City Centre, 83.2% of residents had Canadian citizenship.

# **Regional Comparison of Citizenship**

In 2011, the proportion of residents with Canadian citizenship in Surrey (88.1%) was comparable to that of the Metro Vancouver region (87.9%).





#### **PLACE OF BIRTH**


Place of Birth refers to the province, territory within Canada or country outside of Canada in which a person was born. Boundaries at the current time, not the time of birth, are used to define geographic locations.


In 2011, there were 187,840 immigrants residing in Surrey. Immigrants with a place of birth in an Asian country made up the largest proportion of Surrey's population (73.3%).

The proportion of Surrey residents born in India increased between 2001 and 2011. In 2011, 37.6% of Surrey's immigrant population was born in India, compared to 30.8% in 2001. The proportion of residents from the Philippines also increased during this period, from 6.4% in 2006 to 10.8% in 2011.










### Place of Birth in Surrey's Communities


Immigrants born in Asian countries made up the greatest proportion of the immigrant population in all of Surrey's communities. In Newton 80.2% of the immigrant population was born in Asia. Comparatively, in South Surrey, 44.5% of the immigrant population was born in Asia and 40.3% of the immigrant population was born in a European country.

# **Regional Comparison of Place of Birth**


In 2011, 73.3% of Surrey's immigrant population was born in an Asian country. Comparatively, across the Metro Vancouver region, 68.7% of immigrants were born in an Asian country. Surrey had proportionately fewer immigrants born in a European country (13.6%) compared to other Metro Vancouver municipalities.




#### RECENT IMMIGRATION

Recent immigrants are immigrants who landed in Canada between January 1, 2006 and May 10, 2011. Immigrant refers to a person who is or has ever been a landed immigrant / permanent resident and has been granted the right to live in Canada permanently by immigration authorities.


In 2011, 29,745 of Surrey's residents immigrated to Canada from an Asian country. The largest proportion of recent immigrants in Surrey were from India (40.8%), followed by the Philippines (16.3%) and China (8.5%).





## **Recent Immigration in Surrey's Communities**

In 2011, Newton (89.2%), Fleetwood (88.7%), and Whalley (86.6%) had the greatest proportion of recent immigrants born in Asian countries of all Surrey communities. Cloverdale had comparatively fewer recent immigrants born in Asian countries (55.4%) and a comparatively greater proportion of recent immigrants born in European (17.3%) or African (12.4%) countries.



In 2011, Newton had the most recent immigrants born in India (8,400), and Guildford had the most recent immigrants born in the Philippines (1,775). The largest number of recent immigrants born in China was in South Surrey (1,240).

# **Regional Comparison of Recent Immigration**

In 2011, Surrey had the second largest proportion of recent immigrants born in Asia (85.3%) after Richmond (91.9%). Comparatively, across the Metro Vancouver region 78.4% of recent immigrants were born in an Asian country.
