SUBJECT: Award of Contract No. 1220-040-22-049

Surrey Sports and Leisure Complex - Roof Replacement Phase 1

#### RECOMMENDATION

The Planning & Development Department recommends that Council:

- Award Contract No. 1220-040-2022-049 to Mack Kirk Roofing and Sheet Metal Ltd. for \$505,575.00 (including applicable taxes) for the Surrey Sports and Leisure Complex Roof Replacement Phase 1;
- 2. Set the expenditure authorization limit for Contract No. 1220-040-2022-049 at \$550,000.00 (including applicable taxes and contingency); and
- 3. Authorize the Acting General Manager, Planning & Development to execute Contract No. 1220-040-2022-049.

### **INTENT**

The purpose of this report is to seek Council approval to award a Contract for the removal and replacement of the roof at the southeast portion of the Surrey Sports and Leisure Complex (the "Project"), which has reached the end of its service life.

#### DISCUSSION

## **Scope of Work**

This Project consists of the removal and disposal of the existing roofing, as well as supply and installation of the new roof. The existing roof is approximately 28 years old, is in poor condition and has reached the end of its service life. The proposed new roof would have a life span of approximately 25 years.

### **Request for Quotation Results**

On June 9, 2022, Request for Quotations ("RFQ") No. 1220-040-2022-049 was issued for the Project. The RFQ was advertised on both the City and BC Bid websites. A total of nine compliant bids were received:

### **Evaluation**

The RFQ closed on July 6, 2022. City staff and consultants reviewed the RFQ submissions for accuracy, completeness, comparable work experience and compliance with the RFQ. Mack Kirk Roofing and Sheet Metal Ltd. provided the lowest compliant quotation and represents the best value to the City. It is recommended that Mack Kirk Roofing and Sheet Metal Ltd. be awarded Contract No. 1220-040-2022-049.

### **Project Schedule**

The estimated start date for this Project is October 24, 2022, with completion anticipated for December 2022.

### SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0.
