BY-LAW NO. 13482

A by-law to amend the provisions of "Surrey Official Community Plan By-law, 1996, No. 12900," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Official Community Plan By-law, 1996, No. 12900, as amended, is hereby further amended in Division A, of Schedule B. Temporary Use Permit Areas under the heading Temporary Commercial Use Permit Areas by deleting Location 3 on Page SB-2 in its entirety and replacing it with the following:

Location 3: Temporary parking for golf tournament at Northview Golf Course:
