BY-LAW NO. 13489

A By-law to authorize the Discharge of  
Land Use Contract Number 182.

WHEREAS on the 14th day of May, 1976, this City entered into a Land Use Contract with IMPERIAL OIL LTD. and CANADA SAFEWAY LTD. for the use and development of the lands therein described;

Parcel Identifier: 006-727-107, Lot 431, Section 32, Township 2, New Westminster District, Plan 43318

(12830 - 96 Avenue)

AND WHEREAS CEDAR HILLS PLAZA CORP. INC. NO. 555826 has applied for discharge of Land Use Contract No. 182 registered against the title under M48564;

AND WHEREAS, CEDAR HILLS PLAZA CORP. INC. NO. 555826, the present owner of said lands, desires to develop the same otherwise than in accordance with said Land Use Contract;

AND WHEREAS the Council deems it expedient that the rights and obligations created and to be performed under the said Land Use Contract should terminate and be no longer of force or effect;

AND WHEREAS Section 930 of the *Municipal Act*, R.S.B.C., 1996, c.323, as amended provides that a Land Use Contract may only be discharged by by-law and only after a Public Hearing.

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, enacts as follows:

1. THAT the Land Use Contract entered into the 14th day of May, 1976, between the City of Surrey and IMPERIAL OIL LTD. and CANADA SAFEWAY LTD., respecting the use and development of lands known as:

(12830 - 96 Avenue)

registered in the New Westminster Land Title Office on the 3rd day of June, 1976, under M48564, is terminated.

2. THAT the Mayor and City Clerk are hereby authorized to sign and affix the seal of the City to such instrument as will effectually extinguish all rights and obligations created by the Land Use Contract and will release and discharge the Land Use Contract from the records of title to aforesaid lands in the New Westminster Land Titles Office.

3. This By-law may be cited for all purposes as "Surrey Land Use Contract No. 182, Authorization By-law, 1976,

No. 4778, Discharge By-law, 1998, No. 13489."

PASSED FIRST AND SECOND READING on the 6th day of July, 1998.

PUBLIC HEARING HELD thereon on the 27th day of July, 1998.

PASSED THIRD READING on the 27th day of July, 1998.
