

CITY OF SURREY

BY-LAW NO. 13591

A by-law to amend the provisions of "Surrey
Municipal Ticket Information Utilization By-law,
1994, No. 12508," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508," as amended, is hereby further amended as follows:

(1) Sections 3. and 4. are amended by deleting the words "Schedules 2 through 21" and inserting the words "Schedules 2 through 22" in their place.

(2) Section 12 of Schedule 1 is amended by deleting the words, "Surrey Parks and Recreational Facilities Regulation By-law, 1974, No. 4395" and "Administrator of Parks and Recreation, or his designate" and inserting the words, "Surrey Parks, Recreation and Cultural Facilities Regulation By-law, 1998, No. 13480" and "General Manager, Parks, Recreation and Culture, or his or her designate" in their place, respectively.

(3) Schedule 1 is amended by adding new Section 21 immediately after Section 20 as follows:

"21. Surrey Community Improvement and Unsightly Property By-law, 1997, No. 13150	- Manager, Administration & By-law Enforcement - Senior By-law Enforcement Officer - By-law Enforcement Officer - License Inspector"

- (4) Schedule 13 is deleted in its entirety and new Schedule 13, attached hereto and forming part of this By-law as Schedule "A", is inserted in its place.
- (5) Schedule 16 is deleted in its entirety and new Schedule 16, attached hereto and forming part of this By-law as Schedule "B", is inserted in its place.
- (6) New Schedule 22, attached hereto and forming part of this By-law as Schedule "C" is appended after Schedule 21.

2. This By-law shall be cited for all purposes as "Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508, Amendment By-law, 1998, No. 13591."
