BY-LAW NO. 13595

A by-law to amend the provisions of "Electrical Inspection Safety By-law, 1976, No. [4832](#)," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Electrical Inspection Safety By-law, 1976, No. [4832](#)," as amended is hereby further amended as follows:
  - (1) Schedule "A" is deleted in its entirety and new Schedule "A", attached hereto and forming part of this By-law, is inserted in its place.
2. The provisions of this by-law shall come into force and effect on the 1st day of January, 1999.
3. This By-law shall be cited for all purposes as "Electrical Inspection Safety By-law, 1976, No. [4832](#), Amendment By-law, 1998, No. 13595."

PASSED THREE READINGS on the 7th day of December, 1998.

**Schedule "A" to By-law No. 13595**

**SCHEDULE "A" TO BY-LAW NO. 4832**

1. Regular Permits

Fees for regular permits are based on the value of the electrical installation, including all material and labour and fees for design, testing, consulting, and monetary worth of contributed labour and materials.

Permit fees for homeowner permits are based on a deemed installation value of three times the cost of materials.

Value of Electrical Installation	Fee
\$ 0 - \$ 300	\$38.00
\$ 301 - \$ 700	\$62.00
\$ 701 - \$ 1,000	\$87.00
\$ 1,001 - \$ 10,000	\$87.00 (plus \$27.00 per \$1,000) (or part thereof over \$1,000)
\$ 10,001 - \$ 50,000	\$330.00 (plus \$13.00 per \$1,000) (or part thereof over \$10,000)
\$ 50,001 - \$ 100,000	\$850.00 (plus \$9.00 per \$1,000) (or part thereof over \$50,000)
\$ 100,001 - \$ 500,000	\$1,300.00 (plus \$7.25 per \$1,000) (or part thereof over \$100,000)
\$ 500,001 - \$ 1,000,000	\$4,200.00 (plus \$4.25 per \$1,000) (or part thereof over \$500,000)
\$ 1,000,001 - and over	\$6,325.00 (plus \$2.83 per \$1,000) (or part thereof over \$1,000,000)

Electrical Permit fees will be divided into two portions. Ten percent of the estimated Electrical Permit Fee will be deemed applicable to plan checking and 90% of the estimated Electrical Permit fee will be deemed applicable to inspection charges. Where one or more letters of assurance from a registered professional are required, the plan checking amount will be reduced by 10% to a maximum deduction of \$500.

2. The fee for the Extension of a regular permit shall be \$38.00
3. The fee for Reinspection Orders \$50.00

4. Temporary Entertainment Permits

- (a) the fee for a temporary entertainment permit  
(carnival, movie set, etc.)  
either initially or as a renewal shall be \$65.00

5. Annual Permits

Fees for annual permits shall be:

- a. for a commercial or industrial installation
  - i. per kva of service capacity adjusted to nearest dollar \$0.20
  - ii. minimum fee \$75.00
  - iii. maximum fee \$2,060.00
- b. for educational facility installation
  - i. for each classroom, shop, laboratory,  
gymnasium, auditorium \$2.00
  - ii. minimum fee \$72.00
  - iii. maximum fee \$2,000.00
- c. for entertainment equipment set-up
  - i. for each set-up location \$65.00
  - ii. minimum fee \$200.00

6. Survey Permits

- a. The fee for a survey of single or duplex dwellings \$55.00 hr.  
one hour min.
- b. The fee for a survey of commercial or  
industrial premises \$85.00 hr.  
one hour min.

7. Special Inspections

Where an applicant wishes a special inspection not provided  
for in the fee schedule, the fee shall be:

- a. during normal working hours \$55.00 hr.

one hour min.

bb. after hours during which the offices of the City Hall are normally open, the fee, in addition to other required fees, to be based on the time actually spent in making such inspection, including travelling time. \$380.00 plus \$95 per hour for each hour or part thereof beyond 4 hours.
