BY-LAW NO. 13647

A by-law to amend Surrey Zoning By-law, 1993, No. 12000,
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By-law, 1993, No. 12000, as amended, is hereby further amended, pursuant to the provisions of Section 903 of the Municipal Act R.S.B.C. 1996 Chapter 323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By-law, 1993, No. 12000, as amended, as follows:

FROM "ONE ACRE RESIDENTIAL ZONE (RA)"
TO "SINGLE FAMILY RESIDENTIAL ZONE (RF)"

Parcel Identifier: 000-839-477, East Half Lot 5, Section 26,
Township 2, New Westminster District, Plan 16033; and

(15680 - 82 Avenue)

That portion of road lying in Section 26, Township 2, New
Westminster District dedicated by Plan 16033, shown hatched
on Survey Plan attached hereto as Schedule A to this By-law,
certified correct by Eugene Oliver Wong, B.C.L.S., on the
22nd day of January, 1999, containing 509.1 square metres
and called Block A.

(Portion of 157 Street)

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1993, No. 12000,
Amendment By-law, 1999, No. 13647."

PASSED FIRST AND SECOND READING on the 1st day of February, 1999.

PUBLIC HEARING HELD thereon on the 15th day of February, 1999.

PASSED THIRD READING on the 15th day of February, 1999.

RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 4th day of July, 2000.

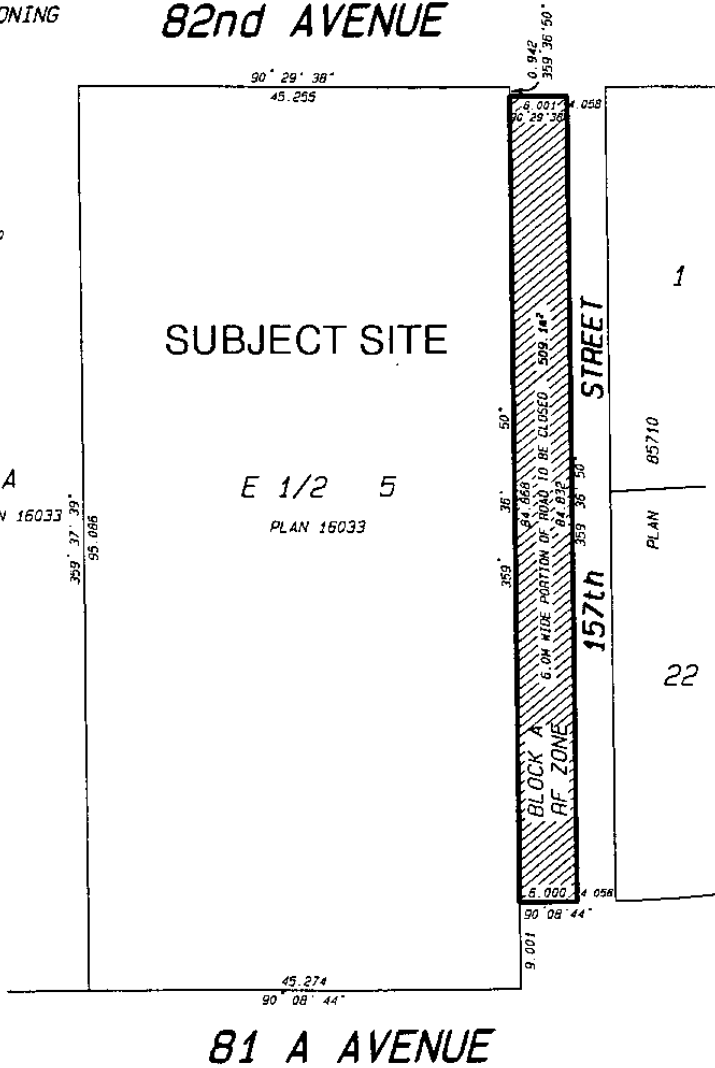
