PUBLIC HEARING HELD thereon on the 15th day of March, 1999.

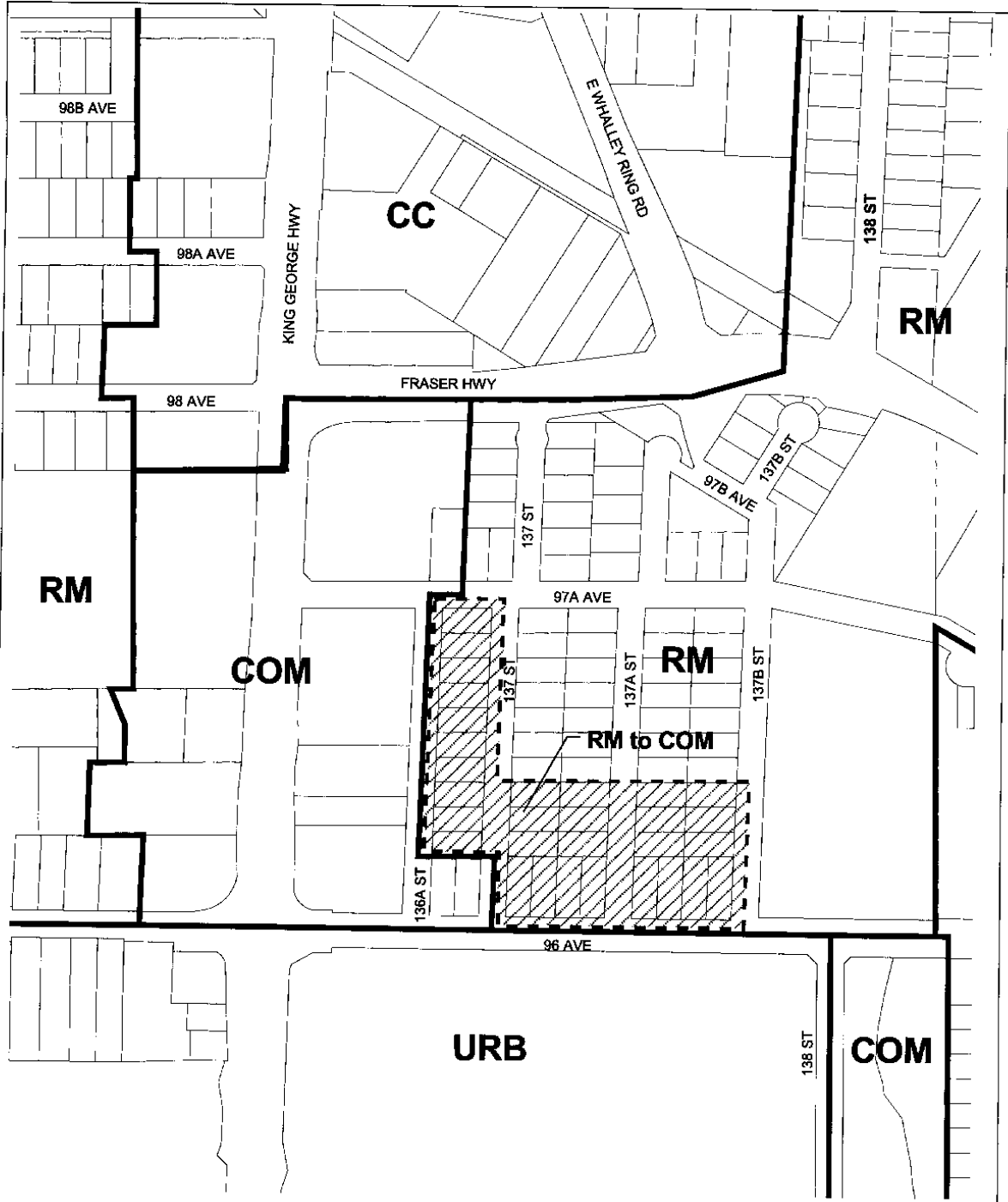
PASSED THIRD READING on the 15th day of March, 1999.
