BY-LAW NO. 16012A

A by-law to amend "Surrey Zoning By-law, 1993, No. 12000,"
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By-law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By-law, 1993, No. 12000, as amended, as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)
TO: SINGLE FAMILY RESIDENTIAL (12) ZONE (RF-12)

Portion of Parcel Identifier: 011-252-154 Block 4 Section 22 Block 5
North Range 1 West New Westminster District Plan 6905, shown on a
Survey Plan attached hereto and forming part of this by-law as Schedule
A, certified correct by Gene Paul Nikula, B.C.L.S. on the 19th day of
April, 2006, called Block A and containing 0.601 hectares and more
particularly described as follows:

(Portion of 10777 - 160 Street)

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1993, No. 12000, Amendment By-law, 2006, No. 16012A."

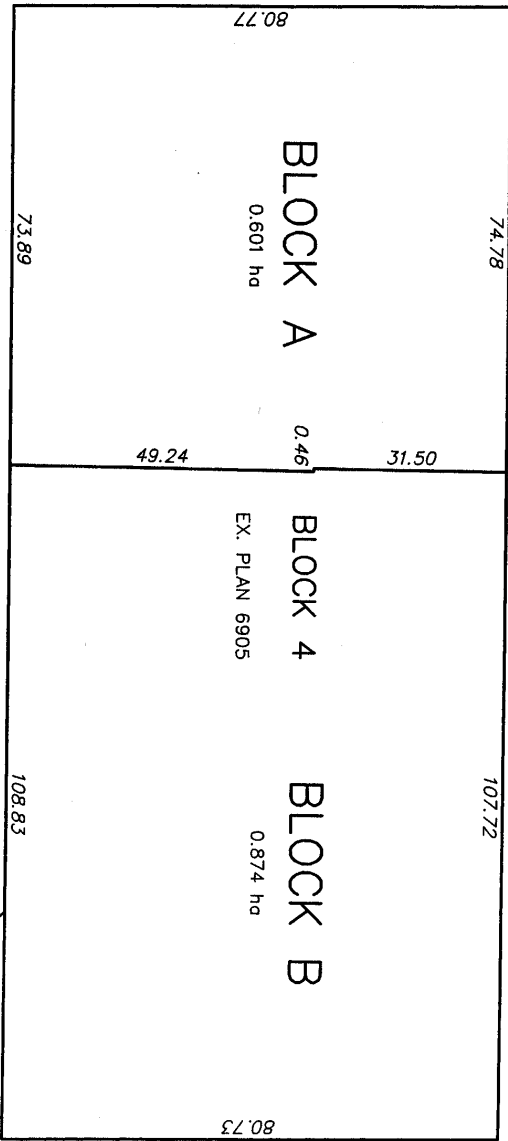
