

CITY OF SURREY
BY-LAW NO. 16532

A by-law to amend the provisions of “Surrey
 Tree Protection By-law, 2006, No. 16100”.

The Council of the City of Surrey, in open meeting assembled, ENACT AS FOLLOWS:

1. “Surrey Tree Protection By-law, 2006, No. 16100,” is hereby further amended as follows:

- (1) Section 36 is amended by replacing the “FIFTY-FIVE (\$55.00) DOLLAR base fee plus TWENTY (\$20.00) DOLLARS” with “FIFTY-SEVEN (\$57.00) DOLLAR base fee plus TWENTY-ONE (\$21.00) DOLLARS”.
- (2) Section 37 is amended by deleting the Zone and Lot Size table and replacing it with the following Zone and Lot Size table:

- (1) Section 39 is amended by deleting the Zone Designation table and replacing it with the following Zone Designation table:

- (1) Section 40 is amended by replacing the “SIXTY (\$60.00) DOLLARS” amount with “SIXTY-TWO (\$62.00) DOLLARS”.
- (2) Section 71 is amended by replacing the “SEVENTY-FIVE (\$75.00) DOLLAR” amount with “SEVENTY-SEVEN (\$77.00) DOLLAR”.

2. This By-law shall be cited for all purposes as “Surrey Tree Protection By-law, 2006, No. 16100, Amendment By-law, 2007 No. 16532”.
