BY-LAW NO. 16721

A by-law to amend "Surrey Zoning By-law, 1993, No. 12000,"
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By-law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By-law, 1993, No. 12000, as amended, as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)
TO: MULTIPLE RESIDENTIAL 30 ZONE (RM-30)

Portion of Parcel Identifier: 012-386-880
Lot 1 Except: Parcel "D" (Explanatory Plan 13056) Section 15 Township
8 New Westminster District Plan 1809, shown on a Survey Plan attached
hereto and forming part of this by-law as Schedule A, certified correct by
R. Janzen, B.C.L.S. on the 7th day of July, 2008, called Block B,
containing 1.51 hectares, and more particularly described as follows:

Portion of 6970 - 192 Street

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1993, No. 12000, Amendment By-law, 2008, No. 16721."

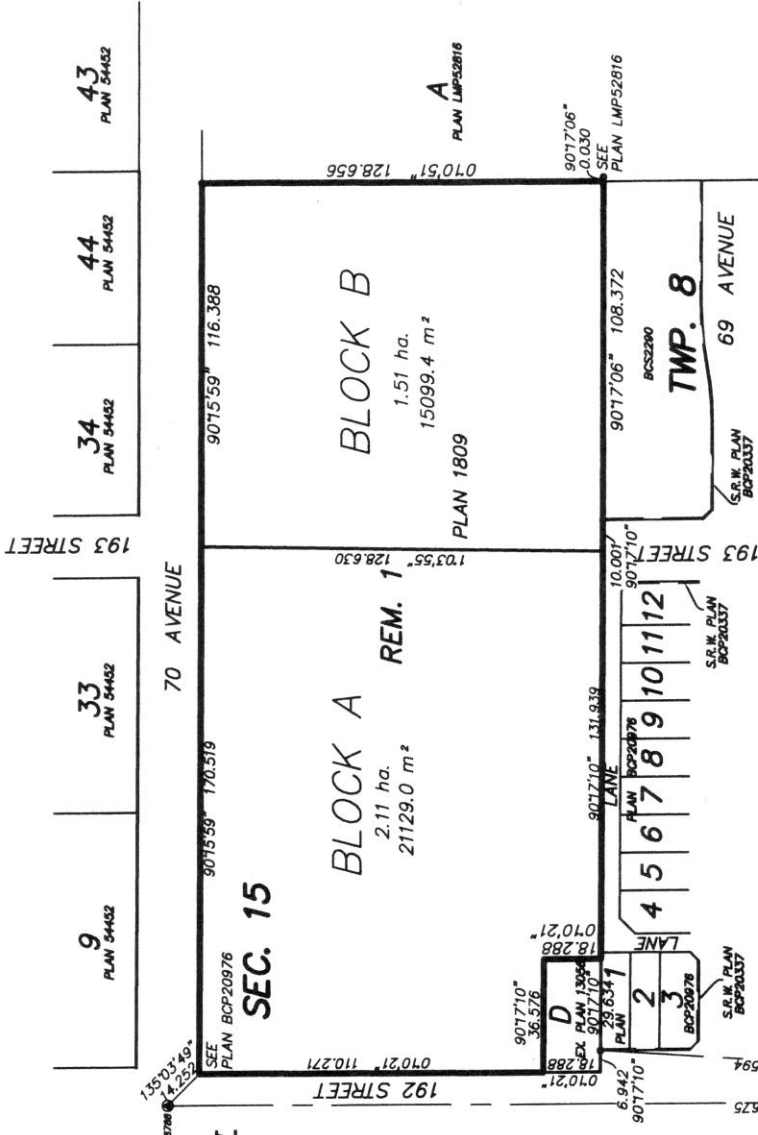
