PUBLIC HEARING HELD thereon on the 25th day of January, 2010.

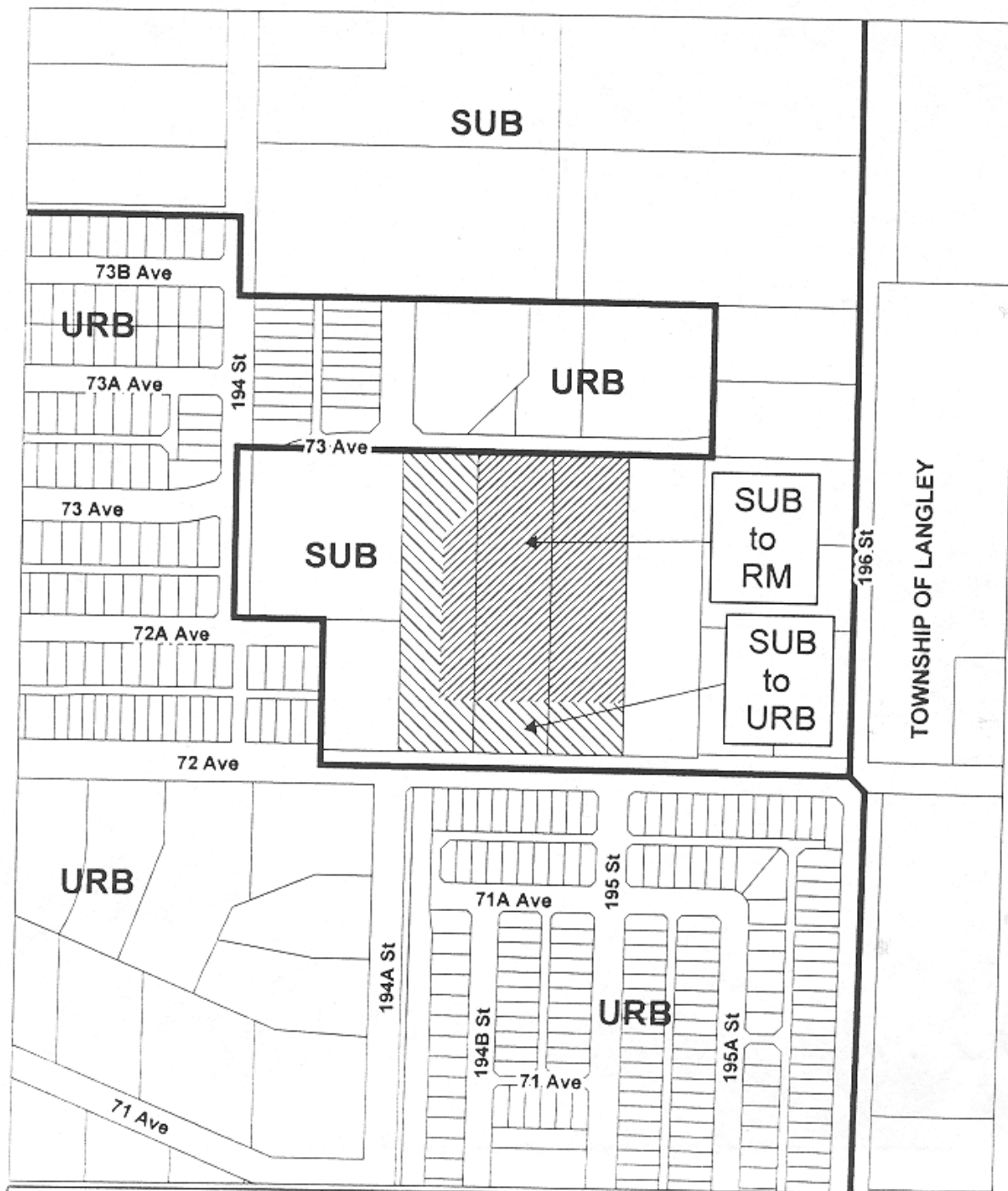
