

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10422

A by-law to amend "Surrey Zoning By-law, 1979, No. [5942](#)."

THE MUNICIPAL COUNCIL of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Surrey Zoning By-law, 1979, No. [5942](#)," as amended, is hereby further amended, pursuant to the provisions of Section 963 of the "Municipal Act," and the classification of the following parcels of land, presently shown upon the maps designated as the "Zoning Maps" and marked as Schedule "A" under PART III of the said By-law No. [5942](#), is hereby amended as follows:

FROM "SUBURBAN RESIDENTIAL ZONE (RS)" AND "AGRICULTURAL ZONE ONE (A-1)" TO "HALF-ACRE RESIDENTIAL - GROSS DENSITY ZONE (R-H(G))"

Parcel "E", (1968OE) of the South West Quarter, Section 36, Township 2, New Westminster District, Plan, hereinafter described as follows:

Commencing at a point on the easterly lot line being measured 213.692 metres north of the southeasterly corner of said lot;

Thence southerly along the easterly lot line to the southeasterly corner of said lot;

Thence westerly along the southerly lot line to the southwesterly corner of said lot;

Thence northerly along the westerly lot line a distance of 64.952 metres;

Thence northeasterly to the point of commencement.

(Portion of 16321 - 88 Avenue)

AND

West 66 Feet of the South Half of the South East Quarter, Section 36, Township 2, EXCEPT: South 33 Feet Included in Said Davis Road, New Westminster District, hereinafter described as follows:

Commencing at a point on the easterly lot line being measured 229.952 metres north of the southeasterly corner of said lot;

Thence southerly along the easterly lot line to the southeasterly corner of said lot;

Thence westerly along the southerly lot line to the southwesterly corner of said lot;

Thence northerly along the westerly lot line a distance of 213.692 metres to a point;

Thence northeasterly to the point of commencement.

(Portion of 16411 - 88 Avenue)

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1979, No. [5942](#), Amendment By-law, 1990, No. 10422."

READ A FIRST AND SECOND TIME on the 19th day of February, 1990.

PUBLIC HEARING HELD thereon on the 19th day of March, 1990.

READ A THIRD TIME ON THE 26th day of March, 1990.

RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 17th day of September, 1990.
