as amended.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled,  
ENACTS AS FOLLOWS:

1. "Surrey Zoning By-law, 1979, No. [5942](#)," as amended, is hereby further amended in PART VI - SIGNS, Section  
C, ADVERTISING SIGNS, Sub-section 1(e) as follows:

(a) The "Height of Free-Standing Sign Map" is hereby amended by including the following within "Area 12":
