

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10472

A by-law to amend "Surrey Zoning By-law, 1979, No. [5942](#)."

THE MUNICIPAL COUNCIL of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Surrey Zoning By-law, 1979, No. [5942](#)," as amended, is hereby further amended, pursuant to the provisions of Section 963 of the "Municipal Act," and the classification of the following parcels of land, presently shown upon the maps designated as the "Zoning Maps" and marked as Schedule "A" under PART III of the said By-law No. [5942](#), is hereby amended as follows:

(a) FROM "SUBURBAN RESIDENTIAL ZONE (RS)"
TO "COMPACT FAMILY RESIDENTIAL ZONE (R-F(C))"

The westerly 302.66m of the South 82.6 Feet, Lot 1, Section 14, Block 5 North, Range 1 West, New Westminister District, Plan 6434, being measured perpendicularly from the westerly lot line.

(Portion of 10956 - 160 Street)

The westerly 302.66m of the North 66 Feet, Lot 2, Section 14, Block 5 North, Range 1 West, New Westminister District, Plan 6434, being measured perpendicularly from the westerly lot line.

(Portion of 10946 - 160 Street)

(b) FROM "SUBURBAN RESIDENTIAL ZONE (RS)" TO "RESTRICTED SINGLE FAMILY RESIDENTIAL ZONE (R-F(R))"

South 82.6 Feet, Lot 1, Section 14, Block 5 North, Range 1 West, New Westminister District, Plan 6434, EXCEPT: that portion described in Sub-Section (a) above;

(Portion of 10956 - 160 Street)

and

North 66 Feet, Lot 2, Section 14, Block 5 North, Range 1 West, New Westminister District, Plan 6434,

EXCEPT: that portion described in Sub-Section (a) above.

(Portion of 10946 - 160 Street)

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1979, No. [5942](#), Amendment By-law, 1990, No. 10472."

READ A FIRST AND SECOND TIME on the 26th day of March, 1990.

PUBLIC HEARING HELD thereon on the 7th day of May, 1990.

READ A THIRD TIME ON THE 14th day of May, 1990.

RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 9th day of December, 1991.
