BY-LAW NO. 10491

A by-law to authorize the purchase of  
lands required for Corporate purposes.

WHEREAS the lands hereinafter described are required for the purpose of the Corporation;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled,  
ENACTS AS FOLLOWS:

1. The Corporation of the District of Surrey is hereby authorized to purchase from the owner or owners thereof  
respectively, the following lands, all in the Municipality of Surrey, Province of British Columbia:

Lot 59, Section 14, Township 1, New Westminster District, Plan 48794

(15812 Norfolk Road)

at or for the sum of Fifty Two Thousand Two Hundred Dollars (\$52,200.00) plus tax adjustment and  
conveyancing costs.

2. Upon receipt of good and valid conveyance of said lands in favour of the Corporation, the Mayor and Treasurer  
are hereby authorized to pay to the owner or owners thereof out of Corporate funds the purchase price as hereinbefore  
mentioned.

3. Upon conveyance of the lands described in Section One (1) hereof to the Corporation, the same shall be and it is  
hereby declared to be set aside and used for Corporate purposes.

4. This By-law may be cited for all purposes as "Land Purchase By-law, 1990, No. 10491."
