BY-LAW NO. 10876

A by-law to amend the provisions of
"Surrey Zoning By-law, 1979, No. [5942](#),"
as amended.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled,
ENACTS AS FOLLOWS:

1. "Surrey Zoning By-law, 1979, No. [5942](#)," as amended, is hereby further amended as follows:

(a) PART IV - GENERAL PROVISIONS is hereby amended in Section B, USES PERMITTED IN SPECIFIC ZONES, by inserting Sub-Section 4.A, Truck Parking or Storage, after Sub-Section 4, Wrecked Vehicles, as follows:

"4.A Truck Parking or Storage:

Vehicles exceeding 5,000 kilograms (11,023 lbs.) licensed G.V.W. are not permitted to be parked or stored either inside or outside a building or structure on any parcel in a residential zone."

(b) PART XIV - R-A(G) ACREAGE RESIDENTIAL - GROSS DENSITY ZONE and PART XVI - R-H(G) HALF-ACRE RESIDENTIAL - GROSS DENSITY ZONE are hereby amended in Section B, PERMITTED USES, by deleting Sub-Section 5(b) in its entirety.

(c) PART XVII - R-1 RESIDENTIAL ZONE NO. ONE (1) is hereby amended in Section 4(a) by deleting the words and figures "one (1) of which may be a truck not exceeding five thousand (5,000) kilograms (11,023 lbs.) GVW" following the words "Three (3) vehicles".

(d) PART XVIII - R-F FAMILY RESIDENTIAL ZONE is hereby amended in Section B, PERMITTED USES, by deleting Sub-Sub-Section 4(b) in its entirety.

(e) PART XVIII A - R-F(D) FAMILY RESIDENTIAL - DUPLEX ZONE is hereby amended in Section B, PERMITTED USES, by deleting Sub-Section 2(b) in its entirety.

(f) PART XIX - R-F(R) RESTRICTED SINGLE FAMILY RESIDENTIAL ZONE is hereby amended in Section B, PERMITTED USES, by deleting Sub-Sub-Section 3(b)(ii) in its entirety.

(g) PART XX - R-F(F) FLOODPLAIN RESIDENTIAL ZONE is hereby amended in Section B, PERMITTED USES, by deleting Sub-Section 4(b)(ii) in its entirety.

(h) PART XXI - R-F(C) COMPACT FAMILY RESIDENTIAL ZONE is hereby amended in Section B, PERMITTED USES, Sub-Section 2(a), by deleting the words and figures "one (1) of which may be a truck not exceeding five thousand (5,000) kilograms (11,023 lbs.) GVW" after the words "Three (3) vehicles".

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1979, No. [5942](#), Text Amendment By-law, 1991, No. 10876."

READ A FIRST AND SECOND TIME on the 25th day of March, 1991.

PUBLIC HEARING HELD thereon on the 27th day of May, 1991.

READ A THIRD TIME on the 15th day of July, 1991.
