

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10881

A by-law to amend the provisions of "Land Use and Land Use Designation Applications Fees Imposition By-law, 1987, No. 8952" as amended.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Land Use and Land Use Designation Applications Fees Imposition By-law, 1987, No. 8952", as amended, is hereby further amended in SCHEDULE ONE (1) - BY-LAW 8952 by deleting NOTE (4) in its entirety and inserting NOTE (4) in its place as follows:

"(4) Should the applicant withdraw his/her application prior to being considered by Council, refunding (including the applicable Public Hearing fee of \$125, \$600, or \$625), shall be as follows:

(a) File opened, no processing done:

- 1. Initial fee of \$ 500 - refund \$ 460
- 2. Initial fee of \$ 750 - refund \$ 690
- 3. Initial fee of \$ 900 - refund \$ 870
- 4. Initial fee of \$ 975 - refund \$ 950
- 5. Initial fee of \$1,200 - refund \$1,140
- 6. Initial fee of \$1,375 - refund \$1,300
- 7. Initial fee of \$1,350 - refund \$1,300
- 8. Initial fee of \$1,975 - refund \$1,880

(b) Engineering input received, no Planning report drafted or commenced:

- 1. Initial fee of \$ 500 - refund \$ 405
- 2. Initial fee of \$ 750 - refund \$ 595
- 3. Initial fee of \$ 900 - refund \$ 830
- 4. Initial fee of \$ 975 - refund \$ 895
- 5. Initial fee of \$1,200 - refund \$1,060
- 6. Initial fee of \$1,375 - refund \$1,190

7. Initial fee of \$1,350 - refund \$1,210
8. Initial fee of \$1,975 - refund \$1,715

(c) Planning report drafted or commenced:

1. Initial fee of \$ 500 - refund \$ 180
2. Initial fee of \$ 750 - refund \$ 220
3. Initial fee of \$ 900 - refund \$ 660
4. Initial fee of \$ 975 - refund \$ 650
5. Initial fee of \$1,200 - refund \$ 700
6. Initial fee of \$1,375 - refund \$ 700
7. Initial fee of \$1,350 - refund \$ 850
8. Initial fee of \$1,975 - refund \$1,025

(d) Report completed and forwarded to Council:

1. Initial fee of \$ 500 - refund \$ 145
2. Initial fee of \$ 750 - refund \$ 155
3. Initial fee of \$ 900 - refund \$ 630
4. Initial fee of \$ 975 - refund \$ 610
5. Initial fee of \$1,200 - refund \$ 640
6. Initial fee of \$1,375 - refund \$ 620
7. Initial fee of \$1,350 - refund \$ 790
8. Initial fee of \$1,975 - refund \$ 915"

2. This By-law shall be cited for all purposes as "Land Use and Land Use Designation Applications Fees Imposition By-law, 1987, No. 8952, Amendment By-law, 1991, No. 10881."
