BY-LAW NO. 10890

A by-law to amend the provisions of  
"Surrey/British Columbia Amateur  
Softball Association Agreement  
Authorization By-law, 1988, No. 9812," as  
amended.

WHEREAS the Municipal Council may by by-law lease any property owned by the Municipality pursuant to Section 542 of the "Municipal Act," being Chapter 290, R.S.B.C., 1979:

AND WHEREAS the Municipal Council entered into an agreement with the BRITISH COLUMBIA AMATEUR SOFTBALL ASSOCIATION, which agreement is Schedule "A" to "Surrey/British Columbia Amateur Softball Association Agreement Authorization By-law, 1988, No. 9812";

AND WHEREAS it is now deemed advisable to amend the agreement attached to and forming part of said By-law 9812 as amended;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, hereby ENACTS AS FOLLOWS:

1. The Mayor and Clerk are hereby authorized to execute an Agreement on behalf of The Corporation of the District of Surrey, in the form attached hereto and forming Schedule "1" to this by-law with BRITISH COLUMBIA AMATEUR SOFTBALL ASSOCIATION to provide for certain amendments to the agreement which is Schedule "A" attached to and forming part of "Surrey/British Columbia Amateur Softball Association Agreement Authorization By-law, 1988, No. 9812," as amended by By-law No. 10298.
2. This By-law shall be cited for all purposes as "Surrey/British Columbia Amateur Softball Association Agreement Authorization By-law, 1988, No. 9812, Amendment By-law, 1991, No. 10890."

PASSED THREE READINGS by the Municipal Council on the 25th day of March, 1991.

SCHEDULE "1"

THIS AMENDMENT AGREEMENT dated the \_\_\_\_day of \_\_\_\_\_, 1991.

BETWEEN:

THE CORPORATION OF THE DISTRICT OF SURREY, a District Municipality under the Municipal Act of the Province of British Columbia, and having its Municipal Offices at 14245 - 56 Avenue, in the Municipality of Surrey, in the Province of British Columbia

(hereinafter called the "Corporation")

OF THE FIRST PART

AND:

BRITISH COLUMBIA AMATEUR SOFTBALL ASSOCIATION, a body corporate under the provisions of the "Societies Act", Statute of British Columbia, having an address at 1496 West 72 Avenue, in the City of Vancouver, Province of British Columbia

(hereinafter called the "Association")

OF THE SECOND PART

WITNESS THAT WHEREAS:

- A. The Corporation, pursuant to Section 542 of the "Municipal Act", being Chapter 290 R.S.B.C., 1979, did on January 23, 1989, enter into an agreement with the Association to provide for the leasing of certain lands and premises belonging to the Corporation that are described in the agreement.
- B. Pursuant to Section 542 of the Municipal Act, the parties now wish to amend the agreement referred to as Schedule "A" of By-law No. 9812 in the manner set out in this amending agreement.

NOW THEREFORE in consideration of the mutual covenants contained in this amending agreement, the parties agree as follows:

The said Agreement shall be amended as follows:

- 1. Article 4 - CONDITION OF LANDS, Section 4.01(a)(i), 4.01(a)(ii), and 4.01(a)(iii) and Article 7 - USE, Section 7.04 are all hereby amended by adding the words "and Class "B" license" after the words "Class "E" license"

therein.

2. Notwithstanding the date of execution and delivery of this amending agreement it shall be effective as of July 30, 1990.

IN WITNESS WHEREOF the parties hereto have executed these presents as of the day and year first above written, by the Corporation causing these presents to be sealed with the seal of the Corporation by the Mayor and Clerk thereof and by the Association causing its common seal to be affixed in the presence of its duly authorized officer or officers.
