

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 10905

A by-law to amend the provisions of  
"Surrey Waterworks Regulation By-law,  
1969, No. [2932](#)", as amended.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled,  
ENACTS AS FOLLOWS:

1. "Surrey Waterworks Regulation By-law, 1969, No. [2932](#)" as amended, is hereby further amended as follows:

(a) SCHEDULE "B", FLAT RATE CHARGES, is hereby amended by deleting Section 1 and inserting Section 1 in its place as follows:

"1. The following minimum flat rate charges for water service shall apply to all of the waterworks system owned and operated as a self-liquidating utility by The Corporation of the District of Surrey:

(i) To every single dwelling unit, including those within a condominium;

to every church;

to every commercial unit, where the average monthly consumption or use of water does not exceed that of the average single dwelling unit; and

to every commercial unit with a single dwelling unit attached thereto and having plumbing fixtures installed in the dwelling unit only:

(ii) To all duplex houses and apartment houses:

for each dwelling unit contained herein.

(iii) To all commercial buildings containing two (2) or more commercial units, and where the average monthly consumption or use of water does not exceed that of the same number of average single dwelling units:

Annual User Charge	If Paid By <u>Sept. 2</u>	If Paid By <u>July 2</u>
\$104.50	\$99.75	\$95.00

for each commercial unit contained herein.

PROVIDED, HOWEVER, that no charge shall be made or charge imposed on any commercial unit which does not have plumbing fixtures installed therein."

(b) SCHEDULE "C" is hereby amended in Section A, METER RATES, in Sub-Section 1, by deleting the word "quarterly" in the first line.

(c) SCHEDULE "C", SECTION A, METER RATES, is hereby further amended as follows:

(i) The Sub-Section entitled "CONSUMPTION PER FOUR MONTH PERIOD" and "RATE PER FOUR MONTH PERIOD" in Sub-Section 2 is hereby deleted and the Sub-Section entitled "CONSUMPTION PER FOUR MONTH PERIOD" and "RATE PER FOUR MONTH PERIOD" is hereby inserted in its place as follows:

"CONSUMPTION PER FOUR MONTH PERIOD      RATE PER FOUR MONTH PERIOD

- For the first 3,000 cu.ft. or part thereof @ \$35.20
- For the next 11,000 cu.ft. or part thereof @ .90 per 100 cu.ft.
- For the next 12,000 cu.ft. or part thereof @ .75 per 100 cu.ft.
- For the next 20,000 cu.ft. or part thereof @ .64 per 100 cu.ft.
- For the next 40,000 cu.ft. or part thereof @ .49 per 100 cu.ft.
- For the next 40,000 cu.ft. or part thereof @ .40 per 100 cu.ft.
- For the next 40,000 cu.ft. or part thereof @ .39 per 100 cu.ft.
- For the next 40,000 cu.ft. or part thereof @ .37 per 100 cu.ft.
- For the next 40,000 cu.ft. or part thereof @ .36 per 100 cu.ft.
- For the next 40,000 cu.ft. or part thereof @ .35 per 100 cu.ft.

All over 286,000 cu.ft. or part thereof @ .34 per 100 cu.ft."

(ii) Sub-Section 2, Sub-Sub-Section (a) is hereby amended as follows:

(a) The figures "\$7.87" in the second line of the first paragraph are hereby deleted and the figures "\$8.80" are hereby inserted in their place.

(b) The figures "\$7.87" in the third line of the second paragraph are hereby deleted and the figures "\$8.80" are hereby inserted in their place.

(c) The figures "\$4.48" in the fourth line of the second paragraph are hereby deleted and the figures "\$5.01" are hereby inserted in their place.

2. This By-law shall be cited for all purposes as "Surrey Waterworks Regulation By-law, 1969, No. [2932](#), Amendment By-law, 1991, No. 10905."
