BY-LAW NO. 11249

A by-law to designate an area within the Municipality and the lands within such area from which the removal of soil shall be permitted, pursuant to "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)."

WHEREAS by Section 6 of "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)," the Council shall by by-law designate the area or areas within the Municipality and the lands within such areas from which the removal of soil shall be permitted, pursuant to said by-law;

AND WHEREAS application has been made to the Council for the designation of that area of the Municipality hereinafter defined and for a permit to remove soil from land within such defined area;

AND WHEREAS it is deemed expedient to designate the said area of the Municipality as an area from which the removal of soil shall be permitted, pursuant to "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)";

THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. This By-law shall be cited for all purposes as "The Surrey Soil Removal Area No. 22 Designation By-law, 1992, No. 11249."
2. Pursuant to Section 6 of the "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)" and subject to all provisions and regulations of "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#),"

Lot 12, Section 15, Township 7, New Westminster District, Plan 53560; and

(19529 - 16 Avenue)

Parcel "A" (Explanatory Plan 10658), East Half of the South West Quarter, Section 15, Township 7, New Westminster District.

(19565/19571 - 16 Avenue)

is hereby designated an area of the Municipality within which the removal of soil may be permitted and the lands within such designated area from which the removal of soil shall be permitted, pursuant to this By-law, shall be described in the permit issued, pursuant to "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)."

3. The removal of soil from that parcel of land described in Section 2 hereof, in addition to all requirements of "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)," shall be subject to the restrictions and requirements of the Soil Removal Permit.

4. This By-law shall not be passed by Council, until a Public Hearing thereon has been held by the Council, pursuant to the requirements of Section 6 of "The Surrey Soil Removal and Depositing Regulation By-law, 1979, No. [5880](#)."

READ A FIRST AND SECOND TIME on the 23rd day of March, 1992.

PUBLIC HEARING HELD thereon on the 13th day of April, 1992, and rescheduled Public Hearings held on the 22nd day of April, 1992, and the 29th day of April 1992.

READ A THIRD TIME ON THE 4th day of May, 1992.

RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 1st day of June, 1992.
