BY-LAW NO. 11277

A by-law to authorize the leasing of certain lands and premises belonging to The Corporation of the District of Surrey.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. The Municipal Council of The Corporation of the District of Surrey is hereby authorized to lease to:

CRANLEY PLACE COMMUNITY ASSOCIATION, having an

address at 2141 Cranley Place, in the Municipality of Surrey, Province of British Columbia, V4A 7V3

for a term of Five (5) Years commencing on the First (lst) day of April, 1992, and ending on the Thirty-First (31st) day of March, 1997; and yielding and paying therefor during the term hereof the clear annual rent of One Dollar (\$1.00) payable as follows: One Dollar (\$1.00) upon execution of the Indenture, and one Dollar (\$1.00) on each of the annual anniversary dates of such initial payment up to and including the First (1st) day of April, 1966:
