BY-LAW NO. 11434

A by-law to amend the provisions of
"Business License By-law, 1976, No.
4747" as amended.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Business License By-law, 1976, No. 4747" as amended, is hereby further amended in Schedule "A" as follows:

(a) Section 7, Auto Body Repair is hereby amended by deleting the words "that the maximum fee shall not exceed ONE HUNDRED FORTY-SEVEN DOLLARS (\$147.00) for every twelve (12) months, and provided further";

(b) Section 13, Banks is hereby amended by deleting the words "; provided that the maximum fee shall not exceed EIGHT HUNDRED FIFTY-SEVEN DOLLARS (\$857.00) for every twelve (12) months";

(c) Section 49, Manufacturers, Machine Shops is hereby amended by deleting the words "; provided that the maximum fee shall not exceed FOUR HUNDRED EIGHTY-SIX DOLLARS FIFTY CENTS (\$486.50) for every twelve (12) months";

(d) Section 62, Professional Practitioners is hereby amended by deleting the words "; provided that the maximum fee shall not exceed FOUR HUNDRED THIRTY-ONE DOLLARS (\$431.00) for every twelve (12) months";

(e) Section 67, Real Estate Agent or Insurance Agent is hereby amended by deleting the words "; provided that the maximum fee shall not exceed FOUR HUNDRED THIRTY-ONE DOLLARS (\$431.00) for every twelve (12) months";

(f) Section 69, Restaurants, Lunch Rooms, Coffee Shops or Drive-In Restaurants is hereby amended by deleting the words "; provided that the maximum fee shall not exceed FOUR HUNDRED FORTY-ONE DOLLARS FIFTY CENTS (\$441.50) for every twelve (12) months";

(g) Section 87, Trust or Investment or Loan Company is hereby amended by deleting the words "; provided that the maximum fee shall not exceed FOUR HUNDRED THIRTY-SEVEN DOLLARS (\$437.00) for every twelve (12) months"; and

(h) Section 91, Wholesale Merchant is hereby amended by deleting the words "; provided that the maximum fee

shall not exceed FIVE HUNDRED THIRTY-TWO DOLLARS (\$532.00) for every twelve (12) months".

2. This By-law shall be cited for all purposes as "Business License By-law, 1976, No. 4747, Amendment By-law, 1992, No. 11434."
