

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11597

A by-law to provide for the indemnifying
of the Mayor and Councillors out of the
Annual Revenue of the Corporation.

WHEREAS Robert J. Bose has been duly elected Mayor and William A. Fomich, Judith E. Higginbotham, J. Marvin Hunt, Bruce Ralston, Gary T. Robinson, Bonnie G. Schrenk, Judy Villeneuve and Michael Garry Watkins, have respectively been duly elected Councillors of The Corporation of the District of Surrey for the period beginning the first Monday of December 1990 and ending the first Monday of December 1993, and have discharged the duties of their respective offices to date;

AND WHEREAS, pursuant to Section 210 of the "Municipal Act", being Chapter 290 R.S.B.C. 1979 and amendments thereto, the term of office of the Mayor and Councillors runs from the first Monday after the first day of December until noon of the first Monday after the first day of December three years later;

AND WHEREAS Section 267 of the said "Municipal Act" provides for the paying out of the annual revenue an annual indemnity to the Mayor and to the Councillors, and provides that a portion of the remuneration to be paid to the Mayor or to a Councillor shall be paid as an allowance for expenses incidental to the discharge of the duties of his office.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. There shall be paid to the Mayor an annual indemnity of Seventy-Two Thousand Three Hundred Sixty-Two Dollars (\$72,362.00), one-third (1/3) of which shall be paid as an allowance for expenses incidental to the discharge of the duties of office.
2. There shall be paid to each Councillor an annual indemnity of Twenty-Six Thousand Five Hundred Eighty-Four Dollars (\$26,584.00), one-third (1/3) of which shall be paid as an allowance for expenses incidental to the discharge of the duties of office.
3. The annual indemnities to the Mayor and Councillors will be paid as follows: the portion payable in 1992 out of the general revenue for the year 1992 and the portion payable in 1993 out of the general revenue for the year 1993 and the Mayor and Treasurer are hereby authorized to sign and issue cheques in payment thereof, or of such proportion thereof as may from time to time be due.
4. "Surrey Indemnities By-law, 1991, No. 11142" is hereby repealed.

5. This By-law shall be cited for all purposes as "Surrey Indemnities By-law, 1992, No. 11597."

PASSED THREE READINGS by the Municipal Council on the 7th day of December, 1992.
