

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11838

A by-law for the levying of rates for
general municipal purposes and special
services for the year 1993, in the
Municipality of Surrey.

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled,
ENACTS AS FOLLOWS:

1. The following rates are hereby imposed and levied for the year 1993:

(a) For the purpose of providing for all lawful general purposes of the Municipality, including due provision for uncollectable taxes and for taxes that it is estimated will not be collected during the year, there is hereby imposed and levied upon the assessed value of land and improvements taxable for general municipal purposes according to the last revised assessment roll of the Municipality, rates appearing in Column A of Schedule "A" attached hereto and made part of this by-law.

"Improvements" for the purpose of levying rates for general municipal purposes means improvements as defined for that purpose in the "Assessment Act".

(b) For the purpose of providing for the drainage system as authorized by "Pacific Highway Hall's Prairie Road Drainage Area Establishment Construction and Loan By-law, 1967, No. 2593," together with the costs of maintenance and operation thereof, there is hereby imposed and levied upon the assessed value of the land for general municipal purposes according to the last revised assessment roll of the Municipality, in that portion of the Municipality described in the said by-law, rates appearing in Column B of Schedule "A" attached hereto and made part of this by-law.

2. The taxes shall be payable to the Collector of The Corporation of the District of Surrey at the Municipal Hall, Surrey, B.C.

3. This By-law shall be cited for all purposes as "Surrey General Rates Levy By-law, 1993, No. 11838."
