

THE CORPORATION OF THE DISTRICT OF SURREY

BY-LAW NO. 11966

A by-law to dispose of portions of a public highway in exchange for adjoining lands necessary for a public highway.

.....

WHEREAS pursuant to Section 574(1) of the "Municipal Act", being Chapter 290, R.S.B.C., the Council may by by-law dispose of a portion of a highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS RICHARD BEAUDRY, MIKE CATERINO and WILLIAM HALCRO are the owners of the land described in Section 2 of this By-law and have agreed with The Corporation of the District of Surrey to make the exchange hereinafter provided for;

NOW, THEREFORE, the Municipal Council of The Corporation of the District of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Upon receiving from the said RICHARD BEAUDRY, MIKE CATERINO and WILLIAM HALCRO the conveyance or other assurance mentioned in Section 2 hereof, the Mayor and the Clerk of The Corporation of the District of Surrey are hereby authorized, in exchange therefore, to execute and deliver on behalf of The Corporation such conveyance or other assurance as may be necessary for vesting in RICHARD BEAUDRY, MIKE CATERINO and WILLIAM HALCRO, ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

A portion of 121st Street shown dedicated on Plan 454 and distinguished as Parcel "A" (104 square metres) of Section 30, Block 5 North, Range 2 West, New Westminster District, on a Reference Plan prepared by Allen Titley, B.C.L.S., and dated the 5th day of May, 1993;

(Portion of 121 Street between 100 Avenue and 100A Avenue)

A portion of 121st Street shown dedicated on Plan 454 and distinguished as Parcel "C" (616 square metres) of Section 30, Block 5 North, Range 2 West, New Westminster District, on a Reference Plan prepared by Allen Titley, B.C.L.S., and dated the 5th day of May, 1993.

(Portion of 121 Street between 100 Avenue and 100A Avenue)

2. For the purpose of acquiring adjacent lands for a public highway, The Mayor and Clerk are authorized to accept from RICHARD BEAUDRY, MIKE CATERINO and WILLIAM HALCRO, in exchange for the land mentioned in Clause One (1) hereof, the sum of Sixty-Two Thousand Dollars (\$62,000.00), together with such conveyance or other

assurance as may be necessary to vest in the Crown as a public highway, ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Surrey, in the Province of British Columbia:

Parcel "B" (12 square metres) of Lot 1, Section 30, Block 5 North, Range 2 West, New Westminster District, Plan 9913, shown on Reference Plan prepared by Allen Titley, B.C.L.S., and dated the 5th day of May, 1993.

(Portion of 12114 - 100A Avenue)

3. This By-law may be cited for all purposes as "Portion of 121 Street Road Exchange By-law, 1993, No. 11966."

PASSED THREE READINGS by the Municipal Council on the 27th day of July, 1993.

ADVERTISED in the Surrey-North Delta Now newspaper on the 31st day of July, and on the 7th day of August, 1993.
