BY-LAW NO. 12016

A by-law to establish special voting opportunities.

WHEREAS pursuant to Section 99 of the "Municipal Act" the Council of the City of Surrey may, by by-law:

- establish one or more special voting opportunities;
- establish restrictions on persons who may vote at the special voting opportunities; and
- establish the date and voting hours when, and the place where the special voting opportunity is to be conducted;

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

SPECIAL VOTING OPPORTUNITIES

1. As authorized under Section 99 of the "Municipal Act" special voting opportunities are hereby established for a local government election on election day, only for the residents or patients of the facility who would otherwise be unable to vote, at the following places and times:

(a) **SPECIAL VOTING OPPORTUNITY #1**

between the hours of 8:00 a.m. to 8:00 p.m.

This special voting opportunity provides for bedside voting and the presiding election official shall proceed to each room to determine which patients or residents are eligible and wish to vote. Upon determining the eligibility of the elector, the presiding election official shall proceed in accordance with the provisions of "Automated Vote Counting System Authorization and Procedure By-law, 1993, No. [12015](#)."
