BY-LAW NO. 12828

A by-law to amend the provisions of "Surrey
Plumbing By-law, 1981, No. 6569," as amended

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Surrey Plumbing By-law, 1981, No. 6569," as amended, is hereby further amended by deleting Sections 9.6 to 9.13 inclusive and inserting new Sections 9.6 to 9.17 as follows:

	9.15	For the removal and replacement of existing piping in multi-family dwellings per unit	\$16.00	
	9.16	For the Transfer or Assignment of a Plumbing Permit and to record a change of contractor for a project	\$50.00	
	9.17	For the installation of a hydronic heating system for each 1,000 BTUs of the boiler input, a fee of	\$2.00
