

CITY OF SURREY

BY-LAW NO. 12965

A by-law to amend the provisions of
"Business License By-law, 1976, No.
4747," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Business License By-law, 1976, No. 4747," as amended is hereby further amended as follows:

(1) Section 2. Interpretation is amended by inserting the new definition of "Highway" after the definition of "Dining Room" and before the definition of "Hobby Kennel" as follows:

""Highway" includes a street, road, lane, bridge, viaduct and any other way designed or intended for or used by the general public, but does not include a private right-of-way on private property."

(2) Section 2. Interpretation is amended by inserting the new definition of "Peddle" after the definition of "Non-resident Business" and before the definition of "Pedlar" as follows:

""Peddle" means peddle, sell, or offer for sale any goods, wares, merchandise, foodstuff, article or thing to be immediately delivered to the customer."

(3) Section 2. Interpretation, the definition of "Pedlar" is amended by deleting the period after clause (b) and inserting the following:

":or (c) a person who peddles, sells, or offers for sale any goods, wares, merchandise, foodstuff, article or thing at a kiosk within a building that is located in commercial zone."

(4) Section 20. (c) is amended by deleting subparagraphs (i), (ii), (iii) and inserting the following in its place:

"(i) No person shall peddle

(a) on or from a highway;

(b) from a vehicle that is stopped or parked on a highway or on public or private property;

(c) on or from a sidewalk;

(d) on or from a parking lot;

- (e) outside of a building; or
- (f) on or from City property or City right-of-way.

(ii) No Pedlar shall carry on business in a manner which is contrary to the Highway and Traffic By-law, 1997, No. [13007](#) as amended, the Motor Vehicle Act, R.S.B.C. 1996, C.318 as amended, the Highway Scenic Improvement Act, R.S.B.C. 1996, c. 190 as amended and any other City By-law or Provincial statute or regulation enacted to regulate traffic and the use of highways within the City.

(iii) No Pedlar shall pose, erect, or display a sign along a highway or on property except in compliance with Surrey Zoning By-law, 1993, No. 12000 as amended and Highway & Traffic By-law, 1997, No. [13007](#) as amended."

(5) Section 20. (c) is amended by deleting subparagraph (v) and inserting the following in its place:

"(v) Every Pedlar shall comply with the Consumer Protection Act, R.S.B.C. 1996, c.69 as amended.

(vi) Every Pedlar who peddles, sells or offers for sale food or food products shall obtain written approval from the provincial agency responsible for health and safe handling of food products.

(vii) No ice cream vendor shall stand or locate either directly outside or in the normal flow of traffic to a store offering for sale the same or similar items as the ice cream vendor.

(viii) No ice cream vendor shall display any signs other than those which may be permitted on the vehicle used when in use on a highway.

2. This By-law shall be cited for all purposes as "Business License By-law, 1976, No. 4747, Amendment By-law, 1996, No. 12965."

PASSED FIRST READING on the 25th day of November, 1996.

PASSED SECOND AND THIRD READINGS on the 21st day of July, 1997.
