BY-LAW NO. 13268

A by-law to amend Surrey Zoning By-law, 1993, No. 12000,
as amended.

.....

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By-law, 1993, No. 12000, as amended, is hereby further amended, pursuant to the provisions of Section 903 of the Municipal Act R.S.B.C. 1996 Chapter 323, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By-law, 1993, No. 12000, as amended, as follows:

- (a) FROM "ONE-ACRE RESIDENTIAL ZONE (RA)"
TO "ASSEMBLY HALL 1 ZONE (PA-1)"

That portion of Parcel Identifier: 017-515-190, Lot 2,
Section 18, Township 7, New Westminster District, Plan
LMP1957, as shown in heavy outline on Survey Plan
attached hereto and forming a part of this By-law as
Schedule A, certified correct by Allan Olsen, B.C.L.S., on
the 14th day of October, 1997, and containing 2.023
hectares and called Block A.

(Portion of 17029 - 16 Avenue)

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1993, No. 12000, Amendment By-law, 1997, No. 13268."

PASSED FIRST AND SECOND READING on the 28th day of October, 1997.

PUBLIC HEARING HELD thereon on the 17th day of November, 1997.

PASSED THIRD READING on the 17th day of November, 1997.

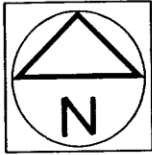
