

CITY OF SURREY

BY-LAW NO. 13300

An Expropriation by-law for the purpose of  
acquiring a Statutory Right-of-Way.  
.....

WHEREAS the Council of the City of Surrey has found it necessary to acquire the within  
described property for the purpose of Statutory Right-of-Way;

AND WHEREAS pursuant to Section 541 of the *Municipal Act*, R.S.B.C. 1996, c. 323, as  
amended of the Province of British Columbia, the City Council may by by-law authorize the  
widening of a highway or any portion of a highway;

AND WHEREAS pursuant to Section 541.(3) of the *Municipal Act*, R.S.B.C. 1996, c.323, as  
amended of the Province of British Columbia, the City Council may acquire property by  
expropriation and have free entry thereon;

NOW, THEREFORE, THE Council of the City of Surrey, in open meeting assembled, ENACTS  
AS FOLLOWS:

1. Pursuant to Section 541 of the *Municipal Act*, R.S.B.C. 1996, c. 323, as amended of the  
Province of British Columbia, the Council of the City of Surrey hereby authorizes the  
expropriation of a temporary Statutory Right-of-Way for the purpose of full, free, and  
unrestricted access, ingress, egress and passage for vehicles, equipment and workmen to  
clear and to deposit, construct, install and maintain preload fill material and temporary  
drainage works in, over, upon and under ALL AND SINGULAR that certain parcel or  
tract of land premises situate, lying and being in the City of Surrey in the Province of  
British Columbia and being:

That portion of Lot "A" Block 18, Section 9, Block 5 North,  
Range 2 West, New Westminster District, Plan 6762, shown as  
Statutory Right-of-Way outlined on Statutory Right-of-Way  
Plan LMP34900, attached hereto and forming a part of this By-law,  
and containing 381.0 square metres.

(Portion of 12983 - 114B Avenue)

2. The Mayor and Clerk are hereby authorized to sign and seal all documents necessary and  
incidental to effect such expropriation.

3. This By-law may be cited for all purposes as "Portion of 12983-114B Avenue Statutory Right-of-Way Expropriation By-law, 1997, No. 13300".

3. This By-law comes in to full force and effect on the date of final adoption.

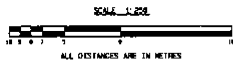

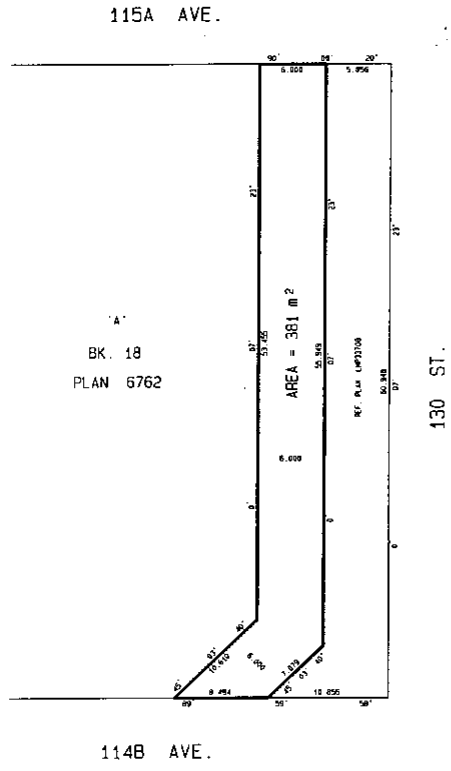
