

CITY OF SURREY

BY-LAW NO. 13316

A by-law to amend the provisions of "Surrey Zoning By-law, 1993, No. 12000," as amended.

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Surrey Zoning By-law, 1993, No. 12000," as amended, is hereby further amended as follows:

(1) Part 1 Definitions is amended as follows:

(a) The definition of "Bingo Hall" is inserted after the definition of "Billboard Sign" and before "Block Watch Sign" as follows:

"Bingo Hall means a recreational facility used or intended to be used for the purpose of playing bingo, where a license has been issued by the British Columbia Gaming Commission to charitable or religious organizations as a licensee, but does not include *casino halls*."

(b) The definition of "Casino Hall" is inserted after the definition of "Care Facility" and before "Child Care Centre" as follows:

"Casino Hall means a *gaming facility* used or intended to be used for the purpose of playing or operating games of chance or mixed chance and skill on which money may be wagered, where a license has been issued by the British Columbia Gaming Commission to charitable or religious organizations as a licensee, but does not include *bingo halls*."

(c) The definition of "Entertainment Uses" is amended by inserting the words "and *casino halls*" after the words "excludes recreational uses" and before the period.

(d) The definition of "Gaming Facility" is inserted after the definition of "Fur Farm" and before "Gasoline Station" as follows:

"Gaming Facility means an establishment which is used or intended to be used for gaming purposes and includes *arcades, casino halls, video lottery gaming* and *slot machine gaming* but excludes *bingo halls* and facilities regulated by the British Columbia Racing Commission."

(e) The definition of "Recreational Facility" is amended by deleting the words "bingo halls" and inserting the words "*bingo halls* and excludes *casino halls*" in their place.

(f) The definition of "Slot Machine Gaming" is inserted after the definition of "Sleeping Unit" and before "Social Escort Service" as follows:

"Slot Machine Gaming means a *gaming facility* containing devices, mechanically, electronically or otherwise operated or intended to be operated for gaming purposes by means of insertion of money or cards or coins equivalent to money."

(2) Part 4 General Provisions is amended as follows:

(a) Sub-section C.1.(a) is amended by deleting the word "Arcades" and inserting the word "*Gaming Facilities*" in its place.

(b) Sub-section C.1.(i) is deleted in its entirety

(3) Sub-section D.12.(e) of Part 5 Parking, and Sub-section B.4. of Part 39 Highway Commercial Industrial Zone (CHI) are amended by italicizing the words "bingo halls."

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1993, No. 12000, Text Amendment By-law, 1998, No. 13316."

PASSED FIRST READING on the 12th day of January, 1998.

PASSED SECOND READING on the 19th day of January, 1998.

PUBLIC HEARING HELD thereon on the 5th day of February, 1998.

PASSED THIRD READING on the 9th day of February, 1998.
