BY-LAW NO. 13337

A by-law to amend the provisions of "Surrey Land Use and Development Applications Fees Imposition By-law, 1993, No. 11631," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

- I. "Surrey Land Use and Development Applications Fees Imposition By-law, 1993, No. 11631," as amended is hereby further amended as follows:
  - (1) SCHEDULE FIVE (5) - APPLICATION FEES WITHIN NEIGHBOURHOOD CONCEPT PLAN AREAS AND INFILL AREAS is amended by deleting the column "Neighbourhood Concept Plan Area/Infill Area" in its entirety and inserting new column "Neighbourhood Concept Plan Area/Infill Area" in its place as follows:

<b>Neighbourhood Concept Plan Area/ Infill Area</b>
(1) North Cloverdale East Neighbourhood Concept Plan Area as shown on Map 1
(2) North Cloverdale West Neighbourhood Concept Plan Area as shown on Map 2
(3) East Newton North Neighbourhood Concept Plan Area as shown on Map 3
(4) West Newton South Neighbourhood Concept Plan Area as shown on Map 4
(5) Rosemary Heights Central Neighbourhood Concept Plan Area as shown on Map 5
(6) West Newton North Neighbourhood Concept Plan as shown on Map 6

(7) West Cloverdale South Neighbourhood Concept Plan Area as shown on Map 7.
(8) Rosemary Heights West Neighbourhood Concept Plan Area as shown on Map 8.

- (2) SCHEDULE FIVE (5) - APPLICATION FEES WITHIN NEIGHBOURHOOD CONCEPT PLAN AREAS AND INFILL AREAS is amended in Section I. Application Surcharge by inserting new Item No. (9) after Item No. (8) as follows:

(9) East Newton South Neighbourhood Concept Plan Area as shown on Map 9	\$68.87 per lot or dwelling unit (or equivalent) calculated on the maximum number of lots or dwelling units allowable on the site after the zoning amendment is granted.

- (3) SCHEDULE FIVE (5) - APPLICATION FEES WITHIN NEIGHBOURHOOD CONCEPT PLAN AREAS AND INFILL AREAS is amended by appending MAP NO. 9 EAST NEWTON SOUTH NEIGHBOURHOOD CONCEPT PLAN LANDS SUBJECT TO SURCHARGE, attached hereto and forming part of this By-law as Schedule A, after MAP NO. 8 ROSEMARY HEIGHTS WEST NEIGHBOURHOOD CONCEPT PLAN LANDS SUBJECT TO SURCHARGE and before SCHEDULE SIX (6) - OTHER APPLICATION FEES.

2. This By-law shall be cited for all purposes as "Surrey Land Use and Development Applications Fees Imposition By-law, 1993, No. 11631, Amendment By-law, 1998, No. 13337."

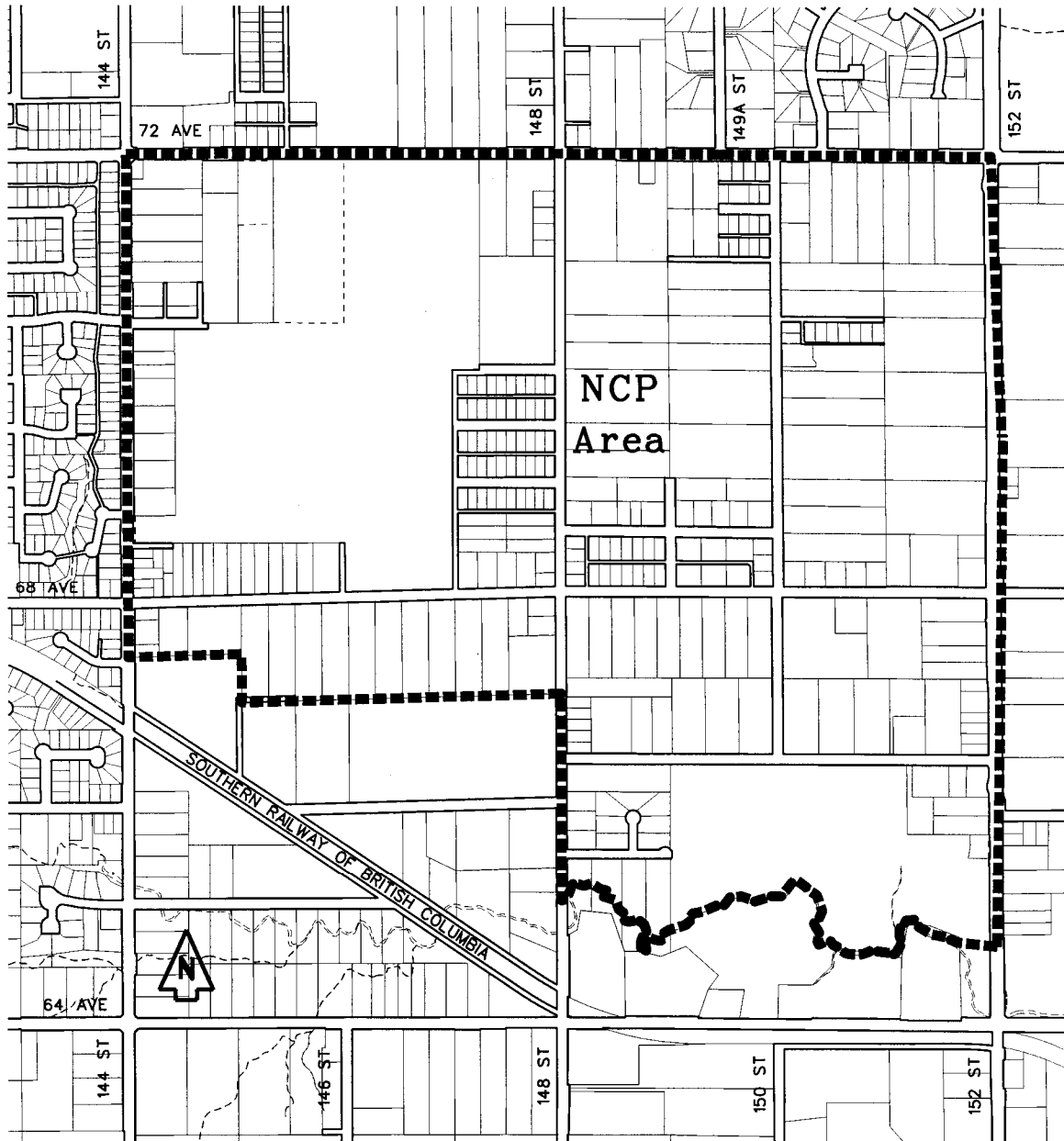
