BY-LAW NO. 13354

A by-law to amend Surrey Zoning By-law, 1993, No. 12000, as amended.
.....

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By-law, 1993, No. 12000, as amended, is hereby further amended, pursuant to the provisions of Section 903 of the Municipal Act R.S.B.C. 1996 Chapter 323, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of the Surrey Zoning By-law, 1993, No. 12000, as amended, as follows:

FROM "SINGLE FAMILY RESIDENTIAL ZONE (RF)"
TO "TOURIST ACCOMMODATION ZONE (CTA)"

That portion of Parcel Identifier: 010-737-146, Parcel "A" (Explanatory Plan 12759) South Half Lot 8, Section 12, Township 1, New Westminster District, Plan 2817, as shown in heavy outline on Survey Plan attached hereto and forming part of this By-law as Schedule A, prepared by Allan Olsen, B.C.L.S., on the 5th day of February, 1997, and containing 438 square metres.

(Portion of 16323 - 8 Avenue)

2. This By-law shall be cited for all purposes as "Surrey Zoning By-law, 1993, No. 12000, Amendment By-law, 1998, No. 13354."

PASSED FIRST AND SECOND READING on the 24th day of February, 1998.

PUBLIC HEARING HELD thereon on the 23rd day of March, 1998.

PASSED THIRD READING on the 23rd day of March, 1998.

RECONSIDERED AND FINALLY ADOPTED, signed by the Mayor and Clerk, and sealed with the Corporate Seal on the 28th day of July, 1998.

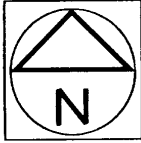

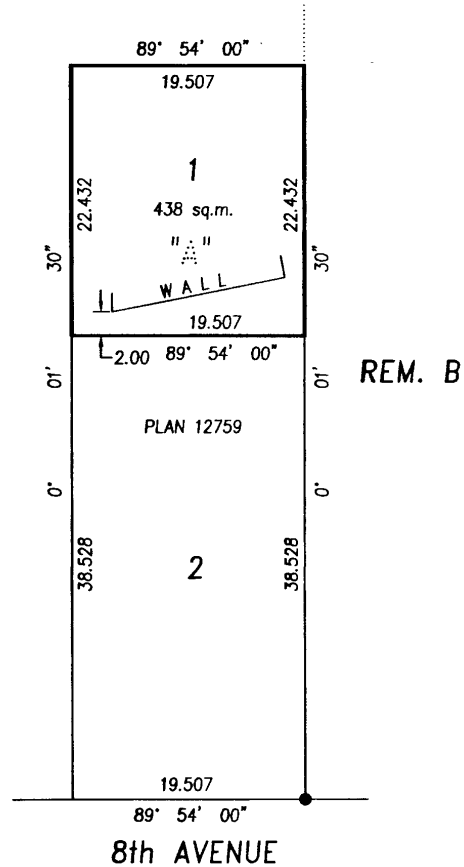
