BY-LAW NO. 14220

A by-law to amend the provisions of "Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. "Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508," as amended is hereby further amended as follows:

(1) Schedule 1 is amended by inserting new Section 23 immediately following Section 22 as follows:

- "23. Public Library Facilities - Manager, By-law & Licensing Services
- Regulation By-law, - Senior By-law Enforcement Officer
- 1999, No. 13804 - By-law Enforcement Officer
- Member of the Royal Canadian Mounted Police"

(2) New Schedule 24, attached hereto and forming part of this by-law, is inserted immediately following Schedule 23.

2. This By-law shall be cited for all purposes as "Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508, Amendment By-law, 2001, No. 14220."
