

CITY OF SURREY

BY-LAW NO. 14536

A by-law to provide for the exemption from taxation of certain properties in the City of Surrey, pursuant to Sections 339 and 340 of the "Local Government Act."

WHEREAS the City Council may, by authority of Sections 339 and 340 of the "Local Government Act" being Chapter 323, R.S.B.C. 1996, as amended, exempt from taxation certain properties;

AND WHEREAS the City Council deems it expedient to exempt from taxation under Sections 339 and 340 the properties hereinafter listed;

NOW THEREFORE the City Council of the City of Surrey, in open meeting assembled, enacts as follows:

Title:

1. This By-law may be cited as the "Section 339 Tax Exemption By-law (#2), 2001, No. 14536".

Exemption:

2. The following lands together with improvements thereon or portions thereof, are hereby exempt from taxation for the year 2002 in the City of Surrey pursuant to Sections 339 and 340 of the Local Government Act, being Chapter 323, R.S.B.C. 1996, as amended:
  - (1) That portion of land and improvements on land legally described as Parcel A, Except: Firstly, part dedicated road on Plan LMP43347 and Secondly, part dedicated road on Plan LMP49714, Section 29, Township 2, New Westminster District, Plan LMP 33700 described as follows:

Commencing at a point immediately east of the roadway located at the northeast corner in Parcel A immediately east of the northeastern corner of the Gurdawara building, thence easterly in a straight line to a point 385.75 feet from the starting point; thence 77 feet south; thence southeast along a curved line shown on the attached sketch 13 feet, 126 feet and 97 feet, thence west in a straight line 308 feet to a point; then north 77 feet to a point, thence east to a point directly south of the north eastern starting point, thence north for 211 feet to join the starting point for a total exemption of 94, 218 square feet with the exempt portion shown hatched on the sketch attached hereto.
