BY-LAW NO. 14576

A by-law to amend the provisions of "Surrey Electrical Inspection Safety By-law, 1976, No. 4832," as amended.

The Council of the City of Surrey, in open meeting assembled, ENACT AS FOLLOWS:

1 "Surrey Electrical Inspection Safety By-law, 1976, No. 4832," as amended is hereby further amended as follows:

1 Schedule A, is amended by replacing the existing schedule A rates with the "Proposed" rates listed as per the attached schedule.

2 This By-law shall be cited for all purposes as "Surrey Electrical Inspection Safety By-law, 1976, No. 4832, amendment By-law, 2001, No. 14576."

ELECTRICAL PERMIT FEES

SCHEDULE "A" TO BY-LAW NO. 4832

1. Regular Permits

Fees for regular permits are based on the value of the electrical installation, including all material and labour and fees for design, testing, consulting, and monetary worth of contributed labour and materials.

Permit fees for homeowner permits are based on a deemed installation value of three times the cost of materials.

Electrical Permit fees will be divided into two portions. Ten percent of the estimated Electrical Permit Fee will be deemed applicable to plan checking and 90% of the estimated Electrical Permit fee will be deemed applicable to inspection charges. Where one or more letters of assurance from a registered professional are required, the plan checking amount will be reduced by 10% to a maximum deduction of \$500.
