

CITY OF SURREY

BY LAW NO. 14805

A by law to amend "Surrey Zoning By law, 1993, No. 12000,"
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By law, 1993, No. 12000, as amended, as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)
 TO: MULTIPLE RESIDENTIAL 15 ZONE (RM-15)

All or portions of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by R.M. Reese, B.C.L.S. on the 28th day of August, 2002, containing 1.164 hectares, called Block "A" and more particularly described as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)
 TO: SINGLE FAMILY RESIDENTIAL ZONE (RF)

Portion of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by R.M. Reese, B.C.L.S. on the 28th day of August, 2002, containing 0.210 hectares, called Block "B" and more particularly described as follows:
