BY-LAW NO. 14907

A by-law to authorize the expenditure
of monies in the "Capital Legacy Reserve Fund".

WHEREAS there is a cash balance in the Capital Legacy Reserve Fund of approximately Twenty-nine Million Seven Hundred Eight-one Thousand Seven Hundred Dollars (\$29,781,700) as at January 1, 2003, pursuant to "Capital Legacy Reserve Fund By-law, 1999, No. 13810",

AND WHEREAS it is deemed desirable to expend the interest earned thereon, during the previous years in the principal contained in the Capital Legacy Reserve Fund, in the amount of Two Million Dollars (\$2,000,000) for the purposes of:

1. Artificial Turf Field	\$1,150,000
2. Road Repaving	500,000
3. Crescent Beach Fire Hall Renovations	250,000
4. Fraser Heights Youth/Water Park	<u>100,000</u>
	<u>\$2,000,000</u>

NOW, THEREFORE, the Council of the City of Surrey, in open meeting assembled, ENACTS THE FOLLOWING:

1. The sum of One Million One Hundred Fifty Thousand Dollars (\$1,150,000) is hereby appropriated from the Capital Legacy Reserve Fund for the purpose of creating an Artificial Turf Field.
2. The sum of Five Hundred Thousand Dollars (\$500,000) is hereby appropriated from the Capital Legacy Reserve Fund for the purpose of repaving Roads.
3. The sum of Two Hundred Fifty Thousand Dollars (\$250,000) is hereby appropriated from the Capital Legacy Reserve Fund for the purpose of renovating the Crescent Beach Fire Hall.
4. The sum of One Hundred Thousand Dollars (\$100,000) is hereby appropriated from the Capital Legacy Reserve Fund for the purpose of creating a Youth/Water Park in Fraser Heights.
5. The expenditures to be carried out by the monies hereby appropriated shall be more particularly specified and authorized by resolution of the Council.
6. Should any of the above amounts remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the said Reserve Fund.

7. This by-law shall be cited for all purposes as “Capital Legacy Reserve Fund Expenditure Authorization By-law, 2003, No. 14907”.

PASSED THREE READINGS by the City Council on the 3rd day of February, 2003.
