

CITY OF SURREY

BY LAW NO. 14953

A by law to amend "Surrey Zoning By law, 1993, No. 12000,"  
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By law, 1993, No. 12000, as amended, as follows:

FROM: SINGLE FAMILY RESIDENTIAL ZONE (RF)  
TO: MULTIPLE RESIDENTIAL 15 ZONE (RM-15)

Portions of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Grant Butler, B.C.L.S. on the 6th day of January, 2003, containing 2.414 hectares, called Block "A" and more particularly described as follows:

Portion of Parcel Identifier: 011-194-120 Lot 7 Except: Part Road on Plan BCP1173  
Section 26 Township 2 New Westminster District Plan 6486; and

(Portion of 15852 Fraser Highway)

Portion of Parcel Identifier: 011-194-138 Lot 8 Except: Part Road on Plan BCP1173  
Section 26 Township 2 New Westminster District Plan 6486.

(Portion of 15878 Fraser Highway)

FROM: SINGLE FAMILY RESIDENTIAL ZONE (RF)  
TO: MULTIPLE RESIDENTIAL 30 ZONE (RM-30)

Portions of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Grant Butler, B.C.L.S. on the 6th day of January, 2003, containing 1.554 hectares, called Block "B" and more particularly described as follows:

Portion of Parcel Identifier: 011-194-120 Lot 7 Except: Part Road on Plan BCP1173 Section 26 Township 2  
New Westminster District Plan 6486; and

(Portion of 15852 Fraser Highway)

Portion of Parcel Identifier: 011-194-138 Lot 8 Except: Part Road on Plan BCP1173

Section 26 Township 2 New Westminster District Plan 6486.

(Portion of 15878 Fraser Highway)

2. This By law shall be cited for all purposes as "Surrey Zoning By law, 1993, No. 12000, Amendment By law, 2003, No. 14953".

PUBLIC HEARING HELD thereon on the 24th day of March, 2003.

PASSED THIRD READING on the 24th day of March, 2003.
