

CITY OF SURREY

BY LAW NO. 15070

A by law to amend "Surrey Zoning By law, 1993, No. 12000,"
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By law, 1993, No. 12000, as amended, as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)

TO: SINGLE FAMILY RESIDENTIAL (9) COACH HOUSE ZONE (RF-9C)

Portion of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Grant Butler, B.C.L.S. on the 3rd day of June, 2003, containing 0.301 hectares, called Area "A" and more particularly described as follows:

Portion of Parcel Identifier: 009-208-381

Lot "C" Except: Parcel "A" (Explanatory Plan 34268) Section 16 Township 8 New
Westminster District Plan 23528

(Portion of 18982 - 72 Avenue)

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)

TO: SINGLE FAMILY RESIDENTIAL (12) COACH HOUSE ZONE (RF-12C)

Portion of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Grant Butler, B.C.L.S. on the 3rd day of June, 2003, containing 1.248 hectares, called Area "B" and more particularly described as follows:

Portion of Parcel Identifier: 009-208-381

Lot "C" Except: Parcel "A" (Explanatory Plan 34268) Section 16 Township 8 New
Westminster District Plan 23528

(Portion of 18982 - 72 Avenue)

2. This By law shall be cited for all purposes as "Surrey Zoning By law, 1993, No. 12000, Amendment By law, 2003, No. 15070."
