

CITY OF SURREY

BY-LAW NO. 15118

A by-law to provide for the exemption from taxation of certain properties in the City of Surrey, pursuant to Sections 339 and 340 of the "Local Government Act."

.....

WHEREAS Council may, by authority of Sections 339 and 340 of the "Local Government Act" being Chapter 323, R.S.B.C. 1996, as amended, exempt from taxation certain properties;

AND WHEREAS Council deems it expedient to exempt from taxation under Sections 339 and 340 the properties hereinafter listed;

NOW, THEREFORE, Council of the City of Surrey, in open meeting assembled, enacts as follows:

**Title**

1. This By-law may be cited as the "Section 339 Tax Exemption By-law, 2003, No. 15118."

**Exemptions**
