

CITY OF SURREY

BY LAW NO. 15160

A by law to amend "Surrey Zoning By law, 1993, No. 12000,"
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By law, 1993, No. 12000, as amended, as follows:

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)
TO: SINGLE FAMILY RESIDENTIAL ZONE (RF)

Portion of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Eugene Wong, B.C.L.S. on the 2nd day of June, 2003, and more particularly described as follows:

Portion of Parcel Identifier: 012-779-563 West Half Lot 8 Section 15 Township 2 New Westminster District Plan 2563, containing 1,889 square metres, and called Block 1:

(Portion of 14708 - 68 Avenue)

Portion of Parcel Identifier: 012-779-555 East Half Lot 8 Section 15 Township 2 New Westminster District Plan 2563, containing 1,889 square metres and called Block 2:

(Portion of 14746 - 68 Avenue)

FROM: ONE-ACRE RESIDENTIAL ZONE (RA)
AND: LIGHT IMPACT INDUSTRIAL ZONE (IL)
TO: SINGLE FAMILY RESIDENTIAL (12) ZONE (RF-12)

Portion of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Eugene Wong, B.C.L.S. on the 2nd day of June, 2003, and more particularly described as follows:

Portion of Parcel Identifier: 012-779-563 West Half Lot 8 Section 15 Township 2 New Westminster District Plan 2563, containing 7,267 square metres, and called Block 4:

(Portion of 14708 - 68 Avenue)

Portion of Parcel Identifier: 012-779-555 East Half Lot 8 Section 15 Township 2 New Westminster District Plan 2563, containing 7,263 square metres and called Block 3:

(Portion of 14746 - 68 Avenue)

2. This By law shall be cited for all purposes as "Surrey Zoning By law, 1993, No. 12000, Amendment By law, 2003, No. 15160."

PASSED FIRST AND SECOND READING on the 27th day of October, 2003.

PUBLIC HEARING HELD thereon on the 17th day of November, 2003.

PASSED THIRD READING on the 17th day of November, 2003.
