BY LAW NO. 15345

A by law to amend "Surrey Zoning By law, 1993, No. 12000,"  
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By law, 1993, No. 12000, as amended, as follows:

FROM: ONE ACRE RESIDENTIAL ZONE (RA)  
TO: SINGLE FAMILY RESIDENTIAL (9) COACH HOUSE ZONE (RF-9C)

Portion of Parcel Identifier: 007-846-371 Lot 2 Section 16 Township 8 New Westminster District Plan 74966 shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Paul Bartlett, B.C.L.S. on the 16th day of February, 2004, called Block A and containing 0.564 hectares, and more particularly described as follows:

(Portion of 19157 - 70 Avenue)

FROM: ONE ACRE RESIDENTIAL ZONE (RA)  
TO: MULTIPLE RESIDENTIAL 30 ZONE (RM-30)

Portions of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Paul Bartlett, B.C.L.S. on the 16th day of February, 2004, called Block B and containing 2.15 hectares, and more particularly described as follows:

Portion of Parcel Identifier: 007-846-371 Lot 2 Section 16 Township 8 New Westminster District Plan 74966

(Portion of 19157 - 70 Avenue)

Portion of Parcel Identifier: 000-720-488 Lot 13 Section 16 Township 8 New Westminster District Plan 52318

(Portion of 7095 - 192 Street)

2. This By law shall be cited for all purposes as "Surrey Zoning By law, 1993, No. 12000, Amendment By law, 2004, No. 15345."
