

CITY OF SURREY

BY LAW NO. 15374

A by law to amend "Surrey Zoning By law, 1993, No. 12000,"
as amended.

The Council of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. Surrey Zoning By law, 1993, No. 12000, as amended, is hereby further amended pursuant to the provisions of Section 903 of the *Local Government Act*, R.S.B.C. 1996, c.323, as amended, by changing the classification of the following parcels of land, presently shown upon the maps designated as the Zoning Maps and marked as Schedule "A" under Part 3 of Surrey Zoning By law, 1993, No. 12000, as amended, as follows:

FROM: ONE ACRE RESIDENTIAL ZONE (RA)
TO: SINGLE FAMILY RESIDENTIAL (9) ZONE (RF-9)

Portions of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Grant Butler, B.C.L.S. on the 11th day of May, 2004, containing 0.460 hectares, called Area A and more particularly described as follows:

Portion of Parcel Identifier: 011-057-572 Lot 18 Except: South 140 Feet Section 10 Township 2 New Westminster District Plan 3981

FROM: ONE ACRE RESIDENTIAL ZONE (RA)
TO: SINGLE FAMILY RESIDENTIAL (12) ZONE (RF-12)

Portions of land shown on a Survey Plan attached hereto and forming part of this by-law as Schedule A, certified correct by Grant Butler, B.C.L.S. on the 11th day of May, 2004, containing 2.75 hectares, called Area B and more particularly described as follows:

Portion of Parcel Identifier: 011-057-572 Lot 18 Except: South 140 Feet Section 10 Township 2 New Westminster District Plan 3981

(Portion of 6084 - 150 Street)

Portion of Parcel Identifier: 004-476-701 Lot "B" Section 10 Township 2 New Westminster District Plan 13385

(Portion of 6132 - 150 Street)

2. This By law shall be cited for all purposes as "Surrey Zoning By law, 1993, No. 12000, Amendment

By law, 2004, No. 15374."
